REGULATION (EEC) No 1397/72 OF THE COMMISSION

of 30 June 1972

fixing the amount of the reimbursement and amount of the levy for offsetting storage costs for sugar for the 1972/73 marketing year

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community;

Having regard to Council Regulation No 1009/67/EEC¹ of 18 December 1967 on the common organization of the market in sugar, as last amended by Regulation (EEC) No 607/72,² and in particular Article 8 (3) thereof;

Whereas Article 8 (1) of Regulation 1009/67/EEC lays down that storage costs for sugar and certain Community syrups shall be reimbursed at a flat rate by the Member States and that Member States shall charge a levy on each sugar manufacturer per unit of weight of sugar produced; whereas, in accordance with the same paragraph, the amount of the reimbursement and the amount of the levy must be the same throughout the Community;

Whereas Article 5 of Council Regulation (EEC) No 750/68³ of 18 June 1968 laying down general rules for offsetting storage costs for sugar, as last amended by Regulation (EEC) No 152/71,⁴ provides that the amount of the reimbursement shall be fixed per month and per unit of weight, taking into consideration the costs of financing and insurance and specific storage costs; whereas Article 3 of Commission Regulation (EEC) No 442/70⁵ of 9 March 1970 laying down detailed rules for the application of the system of offsetting storage costs

for sugar, as amended by Regulation (EEC) No 335/71,6 lays down that the reimbursement shall be fixed per 100 kilogrammes of white sugar;

Whereas the financing costs may, at present, be calculated on the basis of an interest rate of 6.5% per year; whereas insurance costs may be assessed at from 1.5 to 2 per thousand per year; whereas insurance costs and specific storage costs be evaluated at 0.37 units of account per metric ton and per month;

Whereas, pursuant to Article 4 of Regulation (EEC) No 750/68, the quantity in store to be taken into consideration for the reimbursement of one month's storage costs is equal to the average quantities of sugar held in store at the beginning and at the end of the month in question; whereas, for the 1972/73 marketing year, the quantities in store each month may be estimated on the basis of anticipated stocks at the beginning of that year, estimated monthly production, the quantities likely to be imported in the month under consideration and the quantities likely to be disposed of for domestic consumption or exported during the same month; whereas total average monthly stocks during the 1972/73 marketing year can be estimated at approximately 45.5 million metric tons of sugar expressed as white sugar; whereas total reimbursements can thus be estimated at approximately 74 million units of account for the 1972/73 marketing year;

Whereas Article 9 of Regulation (EEC) No 750/68 specifies that the amount of the levy shall be calculated by dividing total anticipated reimbursements by the anticipated quantity of sugar which will be disposed of during the sugar marketing year in question and produced within the maximum quotas; whereas total anticipated reimbursements are to be increased or decreased as the case may be by the amounts carried forward from preceding sugar

marketing years; whereas there is a deficit of 2.756.702 units of account for the 1968/69 to 1970/71 marketing years; whereas the anticipated balance for the 1971/72 marketing year may be assessed as a deficit of 417.000 units of account; whereas Article 3 of Regulation (EEC) No 442/70 lays down that the levy is fixed per 100 kg of white sugar; whereas the quantity of Community sugar which will be disposed of during the 1972/73 marketing year for home consumption or for export may be estimated at approximately 8.1 million metric tons of sugar expressed as white sugar; whereas the amount of the levy should therefore be 0.95 units of account per 100 kilogrammes of white sugar;

Whereas the measures provided for in this Regulation are in accordance with the Opinion of the Management Committee for Sugar;

HAS ADOPTED THIS REGULATION:

Article 1

- 1. For the 1972/73 marketing year, the amount of the reimbursement referred to in Article 8 of Regulation No 1009/67/EEC is hereby fixed at 0·163 units of account per 100 kilogrammes of white sugar per month.
- 2. For the 1972/73 marketing year, the amount of the levy referred to in Article 8 of Regulation No 1009/67/EEC is hereby fixed at 0.95 units of account per 100 kilogrammes of white sugar.

Article 2

This Regulation shall enter into force on 1 July 1972.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
