

REGULATION (EEC) No 1650/72 OF THE COUNCIL

of 31 July 1972

temporarily suspending the autonomous duties in the Common Customs Tariff on certain goods

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community, and in particular Article 28 thereof;

Having regard to the proposal from the Commission;

Having regard to the Opinion of the European Parliament;

Whereas the production of goods specified in this Regulation is at present inadequate or non-existent within the Community, and whereas the producers thus cannot meet the needs of user industries in the Community;

Whereas it is in the interest of the Community to suspend the autonomous duties in the Common Customs Tariff only partially in certain cases, because the goods are produced in the Community, and to effect total suspension in the other cases;

Whereas, in view of the difficulty of assessing accurately short-term trends in the economic

situation in the relevant sectors, suspension measures should be taken only for temporary periods the length of which is to be determined by reference to the interests of Community production;

HAS ADOPTED THIS REGULATION:

Article 1

The autonomous duties in the Common Customs Tariff for the products listed in the Annexes to this Regulation shall be suspended at the level indicated in respect of each of them.

These suspensions shall be valid:

- from 1 July to 31 December 1972 for the products listed in Table I;
- from 1 July 1972 to 30 June 1973 for the products listed in Table II.

Article 2

This Regulation shall enter into force on 1 July 1972.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
