REGULATION (EEC) No 2782/72 OF THE COMMISSION

of 22 December 1972

fixing the standard values of fishery products withdrawn from the market in 1973, to be used in calculating the financial compensation

THE COMMISSION OF THE EUROPEAN COM-MUNITIES,

Having regard to the Treaty establishing the European Economic Community;

Having regard to Council Regulation (EEC) No 2142/70¹ of 20 October 1970 on the common organisation of the market in fishery products, as last amended by the Act annexed to the Treaty concerning the accession of new Member States to the European Economic Community and the European Atomic Energy Community,² signed at Brussels on 22 January 1972, and in particular Article 10 (5) thereof;

Whereas Article 10 of Regulation (EEC) No 2142/72 provides for the grant of financial compensation to producers' organisations which intervene, in certain conditions, in respect of the products listed in Annex I (A) and (C) to that Regulation; whereas the amount of financial compensation must be reduced by standard values for products for purposes other than human consumption;

Whereas Commission Regulation (EEC) No 697/713 of 31 March 1971 determined the ways in which the products withdrawn may be disposed of; whereas the value of such products must be fixed at a standard level for each of these modes of disposal, taking into account the average receipts which may be obtained from such disposal;

Whereas Commission Regulation (EEC) No 2670/714 of 15 December 1971 fixed the standard values for 1972;

Whereas market information relating to those values shows that for most of the uses in question they have been altered during the period just passed; whereas the standard values for 1973 should therefore be fixed in the light of receipts in that period;

Whereas the measures provided for in this Regulation are in accordance with the Opinion of the Management Committee for Fishery Products;

HAS ADOPTED THIS REGULATION:

Article 1

The standard values for calculating the financial compensation provided for in Article 10 of Regulation (EEC) No 2142/72, for products withdrawn by producers' organisations and used for purposes other than human consumption, shall be as shown in the Annex for each of the uses listed therein.

Article 2

This Regulation shall enter into force on 1 January 1973.

It shall apply until 31 December 1973.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
