

REGULATION (EEC) No 3561/73 OF THE COMMISSION
of 21 December 1973
amending Regulation (EEC) No 1109/71 on detailed rules for determining the
entry price for certain fishery products

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community ;

Having regard to Council Regulation (EEC) No 2142/70⁽¹⁾ of 20 October 1970 on the common organization of the market in fishery products, as last amended by Regulation (EEC) No 3159/73⁽²⁾ ;

Whereas Commission Regulation (EEC) No 1109/71⁽³⁾ of 28 May 1971 on detailed rules for determining the entry price for certain fishery products, as last amended by Regulation (EEC) No 2464/72⁽⁴⁾, *inter alia* fixed the quality conversion factors for the calculation of entry prices for products listed in Annex I(A) and (C) to Regulation (EEC) No 2142/70 ; whereas the entry prices arrangements should be extended to frozen mackerel, and a conversion factor for shrimps of size 2, which may now be sold for human consumption, should be fixed ;

Whereas certain conversion factors no longer reflect the exact relationship between the entry prices for the various categories, sizes and presentations of fish and the relevant reference prices, whereas those conversion factors should therefore be brought up to date ;

Whereas the measures provided for in this Regulation are in accordance with the Opinion of the Management Committee for Fishery Products,

HAS ADOPTED THIS REGULATION :

Article 1

Article 1 of Regulation (EEC) No 1109/71 is replaced by the following :

'Article 1

For the purpose of determining entry prices for products listed in Annex I (A) and (C) to Regulation (EEC) No 2142/70, and for frozen mackerel

as mentioned in Annex IV (B) to that Regulation, Member States shall communicate to the Commission, for each of these products and for each representative import market or representative port of importation, the following particulars :

- (a) the prices recorded daily for each quality class or presentation of each product for which prices have been recorded ;
- (b) the origin of the products concerned ;
- (c) the marketing stage at which the prices have been recorded ;
- (d) the quantities in respect of which prices have been recorded, giving separate particulars for each quality class or presentation of each product.'

Article 2

Article 3 of Regulation (EEC) No 1109/71 is replaced by the following :

'Article 3

For each product for which a reference price is fixed, an entry price shall be calculated each market day, on the basis of the quotations recorded, at the first wholesale stage, after unloading in the ports of the Community. As far as the products listed in Annex I(A) and (C) of Regulation (EEC) No 2142/70 are concerned, the entry price is determined for each product category arising out of the application of Article 2 of this Regulation.'

Article 3

Annex I to Regulation (EEC) No 1109/71 is replaced by the Annex to this Regulation.

Article 4

This Regulation shall enter into force on 1 January 1974.
