

**REGULATION (EEC) No 562/74 OF THE COMMISSION**  
**of 8 March 1974**  
**fixing the amount of the subsidy on oil seeds**

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community;

Having regard to Council Regulation No 136/66/EEC<sup>(1)</sup> of 22 September 1966 on the establishment of a common organization of the market in oils and fats, as last amended by Regulation (EEC) No 1707/73<sup>(2)</sup>, and in particular Article 27 (4) thereof;

Whereas the amount of the subsidy referred to in Article 27 of Regulation No 136/66/EEC was fixed by Regulation (EEC) No 1898/73<sup>(3)</sup> and subsequent amending Regulations;

Whereas in the absence of the indicative price for the 1974/75 marketing year for colza and rape seed in case of pre-fixation for the month of July and August 1974 the amount of subsidy on these products has been obtainable only on the basis of the indicative price for the month of July and August 1973, this amount may, therefore, be applied on a temporary basis and should be confirmed or replaced when the indicative price for the 1974/75 marketing year is known;

Whereas it follows from applying the rules and other provisions contained in Regulation (EEC) No 1898/73 to the information at present available to the Commission that the amount of the subsidy at present in force should be altered as shown in the Annex to this Regulation,

HAS ADOPTED THIS REGULATION:

*Article 1*

1. The amount of the subsidy referred to in Article 27 of Regulation No 136/66/EEC is hereby fixed as shown in the Table annexed to this Regulation.
2. The amount of the subsidy for the month of July and August 1974 will, however, as for colza and rape seeds, be confirmed or replaced as from 11 March 1974 to take into account the indicative price which is fixed for these products for the 1974/75 marketing year.

*Article 2*

This Regulation shall enter into force on 11 March 1974.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
