COMMISSION REGULATION (EEC) No 2639/77

of 30 November 1977

fixing the import levies on rice and broken rice

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 1418/76 of 21 June 1976 on the common organization of the market in rice (1), as amended by Regulation (EEC) No 1158/77 (2), and in particular Article 11 (2) thereof,

Whereas the import levies on rice and broken rice were fixed by Regulation (EEC) No 1953/77 (3), as last amended by Regulation (EEC) No 2578/77 (4);

Whereas it follows from applying the rules and other provisions contained in Regulation (EEC) No 1953/77 to the offer prices and today's quotations known to

the Commission that the levies at present in force should be altered as shown in the table annexed to this Regulation,

HAS ADOPTED THIS REGULATION:

Article 1

The import levies to be charged on the products listed in Article 1 (1) (a) and (b) of Regulation (EEC) No 1418/76 are hereby fixed as shown in the table annexed to this Regulation.

Article 2

This Regulation shall enter into force on 1 December 1977.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
