**Corrigendum to Council Regulation (EEC) No 3094/86 of 7 October 1986 laying down certain technical measures for the conservation of fishery resources**

This entry shall read as follows :

'Entire region, except the zone delimited to the North by a line at latitude 52° 30'N and to the East by a line at longitude 7° 00'W.'

Annex I, Region 3, Column entitled 'Geographical area':

for: 'In the bastard sole box (2)',

read: 'In the little sole box (2)'.

Footnote (2) shall be replaced by the following :

(2) The little sole box is defined as an area bounded by a line running from the southern end to the northern end of the bridge linking the mainland of France to the Ile d'Orléron, thence northwards along the west coast of the Ile d'Orléron to Chassiron lighthouse (46° 03'N, 1° 25'W), thence north-westwards to a point on the south coast of the Ile de Ré named "Feu de Chanchardon" (46° 10'N, 1° 28'W), thence along the south coast of the Ile de Ré to Les Baleines lighthouse (46° 15'N, 01° 34'W), thence to a point at latitude 46° 05'N, longitude 1° 44'W, thence to a point at latitude 45° 40'N, longitude 1° 34'W, thence due south to a point at latitude 44° 40'N and 1° 34'W and from this point due east to the coast of France on the western coast of Cap Ferret.'
