

**COMMISSION REGULATION (EEC) No 2852/87**  
**of 24 September 1987**  
**fixing the import levies on frozen sheepmeat and goatmeat**

THE COMMISSION OF THE EUROPEAN COMMUNITIES,  
Having regard to the Treaty establishing the European Economic Community,

Having regard to the Act of Accession of Spain and Portugal,

Having regard to Council Regulation (EEC) No 1837/80 of 27 June 1980 on the common organization of the market in sheepmeat and goatmeat <sup>(1)</sup>, as last amended by Regulation (EEC) No 794/87 <sup>(2)</sup>, and in particular the first paragraph of Article 11 thereof,

Whereas the import levies on frozen sheepmeat and goatmeat were fixed by Commission Regulation (EEC) No 875/87 <sup>(3)</sup>, as last amended by Regulation (EEC) No 2561/87 <sup>(4)</sup>;

Whereas it follows from applying the detailed rules contained in Regulation (EEC) No 875/87 to the quota-

tions and other information known to the Commission that the levies should be altered to the amounts set out in the Annex hereto,

HAS ADOPTED THIS REGULATION:

*Article 1*

The import levies on frozen sheepmeat and goatmeat shall be as set out in the Annex hereto.

*Article 2*

This Regulation shall enter into force on 5 October 1987.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
