

COMMISSION REGULATION (EEC) No 3897/87
of 23 December 1987
concerning the stopping of fishing for sole and plaice by vessels flying the flag of Belgium

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 2241/87 of 23 July 1987 establishing certain control measures for fishing activities ⁽¹⁾, and in particular Article 11 (3) thereof,

Whereas Council Regulation (EEC) No 4034/86 of 22 December 1986, fixing for certain fish stocks and groups of fish stocks, total allowable catches for 1987 and certain conditions under which they may be fished ⁽²⁾, as last amended by Regulation (EEC) No 3545/87 ⁽³⁾, provides for sole and plaice quotas for 1987;

Whereas, in order to ensure compliance with the provisions relating to the quantitative limitations on catches of stocks subject to quotas, it is necessary for the Commission to fix the date by which catches made by vessels flying the flag of a Member State are deemed to have exhausted the quota allocated;

Whereas, according to the information communicated to the Commission, catches of sole in the waters of ICES divisions VII d and of plaice in the waters of ICES division II a (EC zone), IV by vessels flying the flag of Belgium or registered in Belgium have reached the quotas

allocated for 1987; whereas Belgium has prohibited fishing for these stocks as from 20 December 1987; whereas it is therefore necessary to abide by that date;

HAS ADOPTED THIS REGULATION:

Article 1

Catches of sole in the waters of ICES division VII d and of plaice in the waters of ICES division II a (EC zone), IV by vessels flying the flag of Belgium or registered in Belgium are deemed to have exhausted the quotas allocated to Belgium for 1987.

Fishing for sole in the waters of ICES divisions VII d and for plaice in the waters of ICES division II a (EC zone), IV by vessels flying the flag of Belgium or registered in Belgium is prohibited, as well as the retention on board, the transshipment and the landing of such stocks captured by the abovementioned vessels after the date of application of this Regulation.

Article 2

This Regulation shall enter into force on the day of its publication in the *Official Journal of the European Communities*.

It shall apply with effect from 20 December 1987.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
