COMMISSION REGULATION (EEC) No 3938/87

of 23 December 1987

fixing the monetary compensatory amounts applicable in the agricultural sector and certain coefficients and rates required for their application

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Council Regulation (EEC) No 1677/85 of 11 June 1985 on monetary compensatory amounts in agriculture ⁽¹⁾, as last amended by Regulation (EEC) No 1889/87 ⁽²⁾, and in particular Article 12 thereof,

Having regard to Council Regulation (EEC) No 1678/85 of 11 June 1985 fixing the conversion rates to be applied in agriculture ⁽³⁾, as last amended by Regulation (EEC) No 3882/87 ⁽⁴⁾,

Having regard to Commission Regulation (EEC) No 3155/85 of 11 November 1985 establishing advanced fixing of the monetary compensatory amounts ⁽⁵⁾, as last amended by Regulation (EEC) No 1002/86 ⁽⁶⁾,

Whereas, in accordance with Article 1 of Regulation (EEC) No 1677/85, if, for the currency of a Member State, there is a difference between the agricultural conversion rate and the central rate, or, where applicable, the market rate, this Member State must apply monetary compensatory amounts in intra-Community trade and in trade with third countries;

Whereas a Member State for which the central rate, or, where appropriate, the market rate indicates a value for the currency as expressed in ECU higher than the agricultural conversion rate charges monetary compensatory amounts on imports and pays them on exports; whereas these amounts are called 'positive monetary compensatory amounts'; whereas a Member State for which the central rate, or, where appropriate, the market rate expresses a value for a Member State's currency as expressed in ECU lower than the agricultural conversion

rate charges monetary compensatory amounts on exports and pays them on imports; whereas these amounts are called 'negative monetary compensatory amounts';

Whereas, however, the monetary compensatory amounts apply only where the differences between the agricultural conversion rate and the central rate, or, where appropriate, the market rate would cause disturbances in trade in agricultural products;

Whereas, pursuant to the second subparagraph of Article 5 (2) of Regulation (EEC) No 1677/85, the real monetary gap is equal:

- (a) in respect of those Member States whose currencies are maintained as between themselves within a spread at any given time of a maximum of 2,25 %, to the percentage representing, for the currency of the Member State concerned, the difference between:
- the agricultural conversion rate,
 - and
 - the central rate;
- (b) in respect of Member States other than those referred to in (a), to the average of the percentage differences between:
- the rate resulting from the relationship between the agricultural conversion rate for the currency of the Member State concerned and the central rates of each of the currencies of the Member States referred to in (a),
 - and
 - the rate corresponding to the average spot exchange rate of the currency of the Member State concerned in terms of each of the currencies of the Member States referred to in (a), recorded over a period to be determined; whereas this period, under Article 2 (1) of Commission Regulation (EEC) No 3153/85 of 11 November 1985 laying down detailed rules for the calculation of the monetary compensatory amounts ⁽⁷⁾, as amended by Regulation (EEC) No 3770/87 ⁽⁸⁾, runs from the Wednesday of one week to the Tuesday of the following week;

Whereas, notwithstanding the aforementioned Article 5, the central rates to be referred to for the calculation of the compensatory amounts are to be multiplied by a correcting factor, pursuant to Article 6 (1) of Regulation (EEC) No 1677/85;

Whereas the monetary gap to be applied is equal to the real monetary gap minus a neutral margin of:

— 10 points in the olive oil sector,

— 5 points in the wine and poultry sector,

— 1,5 points in all other sectors,

except for the Netherlands where the neutral margin is 1 point;

Whereas, however, a percentage of:

— 0 is applied for as long as, after deduction of the neutral margin, the result obtained is equal to or less than 0,50 but exceeds 0,

— 1 is applied for as long as, after deduction of the neutral margin, the result obtained is equal to or less than 1 but more than 0,50;

Whereas, pursuant to Article 8 of Regulation (EEC) No 3153/85, where there are real monetary gaps differentiated according to product for a Member State, all the monetary compensatory amounts are to be adjusted if the applied monetary gap is adjusted for any one of the products concerned following adjustments of the conversion rates used for calculation of the monetary gaps; whereas the adjustment of the conversion rate for pigmeat pursuant to Article 6a of Regulation (EEC) No 1677/85 is to be considered such an adjustment; whereas, where the monetary gaps are adjusted further to a currency exchange-rate adjustment under the European Monetary System, the monetary compensatory amounts for all Member States are to be recalculated and fixed on the basis of the latest date;

Whereas, in view of the foregoing, the monetary compensatory amount must be calculated by reference to the following gaps for the Member States maintaining their currencies as between themselves within a maximum spread at any one time of 2,25 %:

— *BLEU*:

all sectors 0

— *Denmark*:

all sectors 0

— *Germany*:

milk and milk products + 1,4
cereals + 1,0
other sectors 0

— *France*:

milk — 3,5
cereals — 3,5
wine — 1,0
pigmeat 0
beef and veal — 1,0
eggs, poultry and albumins 0
sugar — 3,5

— *Ireland*

milk and milk products — 3,5
cereals — 3,6
pigmeat — 2,1
beef and veal — 2,0
eggs, poultry and albumins 0
sugar — 3,6

— *Netherlands*:

milk + 1,4
cereals + 1,0
other sectors 0;

Whereas, for the other currencies, under Article 2 (1) of Regulation (EEC) No 3153/85, read with Article 9 (2) of Regulation (EEC) No 1677/85, the monetary compensatory amounts are calculated on the basis of the rates for the reference period from 16 to 22 December 1987 for sterling, the lira, the drachma, the peseta, the escudo; whereas this results in the following monetary gaps to be applied in:

— *United Kingdom*:

milk — 15,8
cereals, sugar — 17,5
pigmeat — 10,9
beef and veal — 8,4
eggs, poultry and albumins — 14,0
olive oil — 9,0

— *Italy*:

milk and milk products, beef and veal, sugar — 4,2
cereals — 5,3
wine — 1,4
pigmeat — 1,6
eggs, poultry and albumins — 1,8
olive oil 0

— *Greece*:

milk and milk products, beef and veal — 44,9
cereals, sugar — 34,7
wine — 31,2
pigmeat — 37,5
eggs, poultry and albumins — 31,2
olive oil — 26,2

— *Spain*:

cereals, sugar — 1,0
other sectors 0

— Portugal

sugar	— 9,2
olive oil	— 1,0;

Whereas Article 6 (1) of Regulation (EEC) No 3155/85 provides that monetary compensatory amounts fixed in advance shall be adjusted if a new agricultural conversion rate which was publicly announced before an application for advance fixing was lodged comes into effect; whereas this situation has arisen in some sectors for Federal Republic of Germany and the Netherlands;

Whereas:

- for the basic products, the monetary compensatory amounts are equal to the amounts obtained by applying the monetary gap to the common prices,
- for derived products, the monetary compensatory amounts are equal to the incidence, on the price of the product concerned, of the application of the monetary compensatory amount to the price of the basic product of products on which they depend;

Whereas poultry products are deemed to be derived from cereals;

Whereas, under Article 6a of Regulation (EEC) No 1677/85 the monetary compensatory amounts in the pigmeat sector are fixed on the basis of a price equal to 35 % of the basic price; whereas, however, the agricultural conversion rates of Member States should be adjusted, so as to avoid the creation of new monetary compensatory amounts; whereas no adjustment may be made that would give a difference for a Member State of more than eight points between the monetary gap applicable in the pigmeat sector and that applicable in the cereals factor;

Whereas, under Article 4 (3) (b) of Regulation (EEC) No 3153/85, for sugar, the monetary compensatory amount is calculated on the basis of the intervention price increased by the amount of the levy charged on sugar of Community origin under the storage cost offsetting scheme;

Whereas, under Article 4 (3) (b) of Regulation (EEC) No 3153/85, for beef and veal, the monetary compensatory amount is calculated on the basis of the intervention price for R3 carcasses of male animals in the Member State concerned, less 20 %;

Whereas, under Article 4 (3) (c) of Regulation 3153/85, for milk and milk products, the monetary compensatory amounts:

- are calculated on the basis of the intervention prices for butter and for skimmed-milk powder, less 5 %,
- for all products except skimmed-milk powder, butter and products falling within subheading 0405 00 90 of the combined nomenclature are calculated without

taking into account the processing costs included in the intervention prices for butter and for skimmed-milk powder;

Whereas, under Article 4 (3) (d) of Regulation (EEC) No 3153/85, for cereals, the monetary compensatory amounts are calculated on the basis of the intervention prices for the products concerned, less 7,5 %;

Whereas, under Article 4 (3) (e), for wine, the monetary compensatory amount is calculated on the basis of the minimum guaranteed price referred to in Article 29 of Council Regulation (EEC) No 822/87⁽¹⁾, as last amended by Regulation (EEC) No 3146/87⁽²⁾;

Whereas pursuant to Article 4 (3) (g), as regards olive oil, the monetary compensatory amounts are calculated on the basis of the following prices:

1510 00 90	Price used for subheading 1510 00 10, multiplied by a coefficient of 1,22

Whereas, for olive oils put up in a way meeting the requirements for the granting of the consumption aid and for the release to free circulation of olive oil from third countries, the monetary compensatory amount is to be calculated on the basis of the price laid down in the previous subparagraph minus the consumption aid, after deduction of the amount withheld pursuant to Article 11 (6) of Council Regulation (EEC) No 136/66/EEC⁽³⁾, as last amended by Regulation (EEC) No 1915/87⁽⁴⁾, for information and promotion purposes;

Whereas, pursuant to Article 5 of Regulation (EEC) No 3153/85, as regards merchandise coming under Council Regulation (EEC) No 3033/80⁽⁵⁾, as amended by Regulation (EEC) No 3743/87⁽⁶⁾, the monetary compensatory amounts are not applicable for:

- products falling within subheadings 2007 91 10, 2007 91 30, 2007 91 90, 2007 99 20 and 2007 99 57 of the combined nomenclature and covered by Council

Regulation (EEC) No 426/86 ⁽¹⁾, as last amended by Regulation (EEC) No 1928/87 ⁽²⁾, with a sugar content of more than 50 % by weight,

- goods covered by Council Regulation (EEC) No 3033/80,

where the monetary compensatory amount is less than the equivalent of 3 ECU per 100 kg of goods;

Whereas the specific characteristics of 'Retsina' table wine warrant the non-application of monetary compensatory amounts for this product;

Whereas the monetary compensatory amounts apply in trade between the Member States and with third countries; whereas, however:

- in trade with a new Member State, the accession compensatory amounts, the fixed components and other amounts provided for under accession measures, and
- in trade with third countries, import charges, or parts thereof, and import subsidies and export refunds and levies

which are fixed in ECU and apply to products subject to monetary compensatory amounts are multiplied by the monetary coefficient;

Whereas, for goods coming under Regulation (EEC) No 3033/80, the import charges are fixed in a single amount; whereas, on the other hand, refunds are those applicable for the basic products from which this merchandise is obtained; whereas this should therefore be allowed for when the monetary coefficients to be applied for the relevant merchandise are fixed;

Whereas Article 10 (1) of Regulation (EEC) No 1677/85 stipulates that where a product exported from one Member State has been imported into a Member State which has to grant a monetary compensatory amount upon importation, the exporting Member State may, by agreement with the importing Member State, pay the monetary compensatory amount which should otherwise be granted by the said importing Member State; whereas, the application of this provision requires the fixing of conversion rates expressing the monetary compensatory amounts concerned in the currencies of the other Member States;

Whereas Article 6 of Regulation (EEC) No 3155/85 stipulates that monetary compensatory amounts fixed in advance must be adjusted where a new representative rate takes effect during the period of validity of the certificate; whereas this new rate must have been fixed before the application for the certificate was submitted;

whereas these adjustments can be effected by applying coefficients to the relevant monetary compensatory amounts;

Whereas the new monetary compensatory amounts must be applied in compliance with the date on which the changes in the basic factors for calculating the monetary compensatory amounts take effect;

Whereas Council Regulation (EEC) No 2658/87 on the tariff and statistical nomenclature and on the Common Customs Tariff ⁽³⁾ introduces, with effect from 1 January 1988, a new combined nomenclature, which meets the requirements of both the Common Customs Tariff and the Community's statistics on foreign trade and which replaces the existing nomenclature; whereas, accordingly, the codes of the combined nomenclature should be introduced for the monetary compensatory amounts;

Whereas, it should be made clear that the codes used are those of the combined nomenclature as defined by Regulation (EEC) No 2658/87; whereas the additional codes are defined in the tables in the Appendix to Annex I to this Regulation and whereas the additional table numbers shown in the parts refer to the chapter indicated in the first two headings of the codes of the combined nomenclature;

Whereas monetary compensatory amounts now applying and certain coefficients and rates for that application have been fixed by Commission Regulation (EEC) No 1956/87 ⁽⁴⁾, as last amended by Regulation (EEC) No 3876/87 ⁽⁵⁾; whereas this Regulation can be repealed;

Whereas the measures provided for in this Regulation are in accordance with the opinions of the relevant management committees,

HAS ADOPTED THIS REGULATION:

Article 1

The monetary compensatory amounts referred to in Article 1 of Regulation (EEC) No 1677/85 are hereby fixed for the Member States concerned as set out in Annex I.

Article 2

The coefficients referred to in Article 6 (3) of Regulation (EEC) No 3153/85 are hereby fixed as set out in Annex II.

Article 3

The exchange rates to be used for the application of Article 10 of Regulation (EEC) No 1677/85 are hereby fixed as set out in Annex III.

Article 4

The coefficients for carrying out the adjustments to be made, pursuant to Article 6 (1) of Regulation (EEC) No 3155/85, to monetary compensatory amounts fixed in advance are shown in Annex IV hereto.

Article 5

Regulation (EEC) No 1956/87 is hereby repealed.

Article 6

This Regulation shall enter into force on the day of its publication in the *Official Journal of the European Communities*.

It shall apply with effect from 1 January 1988.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
