

**COMMISSION REGULATION (EEC) No 4147/88**

of 21 December 1988

amending Regulation (EEC) No 1767/82 as regards the fixing of quantities of  
cheeses imported from Norway

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 804/68 of 27 June 1968 on the common organization of the market in milk and milk products <sup>(1)</sup>, as last amended by Regulation (EEC) No 1109/88 <sup>(2)</sup>, and in particular Article 14 (7) thereof,

Whereas, under the new Agreement in the form of an Exchange of Letters concluded between the Community and Norway on 21 December 1988 <sup>(3)</sup>, annual tariff quotas were fixed for the Community and Norway for 1989, 1990 and 1991; whereas the entry opposite Norway in Annex I to Commission Regulation (EEC) No 1767/82 of 1 July 1982 laying down detailed rules for applying specific import levies on certain milk products <sup>(4)</sup>, as last amended by Regulation (EEC) No 3852/88 <sup>(5)</sup>, should be amended accordingly;

Whereas the measures provided for in this Regulation are in accordance with the opinion of the Management Committee for Milk and Milk products,

HAS ADOPTED THIS REGULATION:

*Article 1*

Point (s) in Annex I to Regulation (EEC) No 1767/82 is hereby replaced by the following:

*Article 2*
