THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Council Regulation (EEC) No 804/68 of 27 June 1968 on the common organization of the market in milk and milk products (1), as last amended by Regulation (EC) No 1538/95 (2), and in particular Articles 6 (6), 7 (5), 7a (1) and (3), 10 (3) and 12 (3) thereof,

Having regard to Council Regulation (EEC) No 739/93 of 17 March 1993 on the application of the common price for milk powder in Portugal (1), and in particular Article 3 thereof,

Having regard to Council Regulation (EEC) No 2019/93 of 19 July 1993 introducing specific measures for the smaller Aegean islands concerning certain agricultural products (2), as last amended by Regulation (EC) No 1363/95 (3), and in particular Article 4 thereof,

Having regard to Council Regulation (EEC) No 3641/93 of 20 December 1993 on certain procedures for applying the Interim Agreement on trade and trade-related matters between the European Economic Community and the European Coal and Steel Community of the one part, and the Republic of Bulgaria of the other part (4), and in particular Article 1 thereof,

Whereas the value in ecus of certain prices and amounts was modified, with effect from 1 February 1995, by virtue of Article 13 (2) of Council Regulation (EEC) No 3813/92 of 28 December 1992 on the unit of account and the conversion rates to be applied for the purposes of the common agricultural policy (5), as last amended by Regulation (EC) No 150/95 (6), in order to cancel the effects of abolishing the correction factor of 1,207509, which applied until 31 January 1995 to conversion rates used in agriculture; whereas the new ecu values of the prices and amounts concerned were established from 1 February 1995 in accordance with the rules laid down in Article 13 (2) of Regulation (EEC) No 3813/92 and in Article 18 (1) of Commission Regulation (EEC) No 1068/93 of 30 April 1993 on detailed rules for determining and applying the agricultural conversion rates (7), as last amended by Regulation (EC) No 1053/95 (8);

Whereas, in accordance with Article 18 (2) of Regulation (EEC) No 1068/93 in order to avoid confusion and facilitate the application of the common agricultural policy, it is necessary to replace the value in ecus of the prices and amounts concerned where they are applicable at least

- 1 January 1996 in respect of the amounts not concerned by a marketing year,
- the beginning of the 1996 marketing year in the case of prices or amounts for which the marketing year starts in January 1996,
- the beginning of the 1995/96 marketing year in the other cases,

which appear in regulations that came into force before 1 January 1995;

Whereas, in order to facilitate administration of the measures concerned, it is necessary in respect of certain amounts in the milk and milk products sector to provide for a rounding-off reducing the number of decimal places referred to in Article 18 (1) of Regulation (EEC) No 1068/93:

HAS ADOPTED THIS REGULATION:

Article 1

Consequent to the adjustment, pursuant to Article 13 (2) of Regulation (EEC) No 3813/92 and Article 18 (1) of Regulation (EEC) No 1068/93, applicable from 1 February 1995, certain prices and amounts expressed in ecus in the milk and milk products sector are hereby amended as set out in the Annex hereto.

Article 2

This Regulation shall enter into force on the seventh day following its publication in the Official Journal of the European Communities.
