COMMISSION REGULATION (EC) No 693/95

of 30 March 1995

amending Regulation (EEC) No 1756/93 fixing the operative events for the agricultural conversion rate applicable to milk and milk products

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Council Regulation (EEC) No 3813/92 of 28 December 1992 on the unit of account and the conversion rates to be applied for the purposes of the common agricultural policy (1), as last amended by Regulation (EC) No 150/95 (2), and in particular Article 6 (2) thereof,

Whereas the purpose of Commission Regulation (EEC) No 1756/93 (3), as last amended by Regulation (EC) No 267/95 (*), is precisely to fix the agricultural conversion rate to be applied to all amounts fixed in ecus in the milk and milk products sector; whereas Commission Regulation (EEC) No 685/69 of 14 April 1969 on detailed rules of application for intervention on the market in butter

HAS ADOPTED THIS REGULATION :
