

Commission Regulation (EC) No 1471/2007 of 13 December 2007  
amending Regulation (EC) No 753/2002 laying down certain rules for  
applying Council Regulation (EC) No 1493/1999 as regards the description,  
designation, presentation and protection of certain wine sector products

Article 1 **U.K.**

Regulation (EC) No 753/2002 is amended as follows:

1. In the first paragraph of Article 28 the following indent is added:
  - “regional vin” in the case of table wines originating in Denmark,
2. Article 29 is amended as follows:
  - (a) in paragraph 1, point (b) is replaced by the following:
    - (b) Germany:  
accompanying the indication of origin of the wine
      - “Qualitätswein”,
      - “Prädikatswein”, supplemented by “Kabinett”, “Spätlese”, “Auslese”, “Beerenauslese”, “Trockenbeerenauslese” or “Eiswein”,
      - “Qualitätswein mit Prädikat”, supplemented by “Kabinett”, “Spätlese”, “Auslese”, “Beerenauslese”, “Trockenbeerenauslese” or “Eiswein” until 1 August 2009;
    - (b) in paragraph 1, point (o) is replaced by the following:
      - (o) Slovenia:
        - “kakovostno vino z zaščitenim geografskim poreklom” or “kakovostno vino ZGP”; these terms may be supplemented by the expression “mlado vino”,
        - “vino s priznanim tradicionalnim poimenovanjem”, “vino PTP” or “renome”,
        - “vrhunsko vino z zaščitenim geografskim poreklom”, “vrhunsko vino ZGP” or “eminentno”; this term may be accompanied by “pozna trgatev”, “izbor”, “jagodni izbor”, “suhi jagodni izbor”, “ledeno vino”, “vino iz sušenega grozdja”, “arhivsko vino”, “arhiva”, “starano vino” or “slamno vino”;
    - (c) in paragraph 1, point (p) is replaced by the following:
      - (p) Slovakia:  
names accompanying the indication of origin of the wine:
        - “akostné víno”,
        - “akostné víno s prívlastkom” plus “kabinetné”, “neskorý zber”, “výber z hrozna”, “bobuľový výber”, “hrozienský výber”, “cibébový výber”, “slamové víno”, “ľadový zber”,as well as the following expressions:

- (j) Slovakia:
- “sekt vinohradníckej oblasti”,
  - “pestovateľský sekt”.

3. Annex III is amended in accordance with the Annex to this Regulation.

*Article 2* **U.K.**

This Regulation shall enter into force on the day of its publication in the *Official Journal of the European Union*.

Article 1(2)(a) and (d) and Article 1(3) shall apply from 1 August 2007.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
