Commission Regulation (EU) No 347/2012 of 16 April 2012 implementing Regulation (EC) No 661/2009 of the European Parliament and of the Council with respect to type-approval requirements for certain categories of motor vehicles with regard to advanced emergency braking systems

Article 1

Scope

This Regulation applies to motor vehicles of categories M_2 , M_3 , N_2 and N_3 , as defined in Annex II to Directive 2007/46/EC, with the exception of the following:

- (1) semi-trailer towing vehicles of category N_2 with a maximum mass exceeding 3,5 but not exceeding 8 tonnes;
- (2) categories M₂ and M₃ vehicles of Class A, Class I and Class II;
- (3) category M₃ articulated buses of Class A, Class I and Class II;
- (4) off-road vehicles of categories M₂, M₃, N₂ and N₃ as referred to in points 4.2 and 4.3 of Part A of Annex II to Directive 2007/46/EC;
- (5) special purpose vehicles of categories M₂, M₃, N₂ and N₃ as referred to in point 5 of Part A of Annex II to Directive 2007/46/EC;
- (6) vehicles of categories M_2 , M_3 , N_2 and N_3 with more than three axles.
