CHAPTER II

Control system and administrative penalties in relation to cross-compliance

[^{F2}Article 101

^{F1}... Powers in relation to the application and calculation of administrative penalties

1 In order to ensure a correct distribution of the funds to the entitled beneficiaries and that cross-compliance is carried out in an efficient, coherent and non-discriminatory way, the [^{F3}appropriate authority may make regulations]:

- b laying down the conditions for the application and calculation of the administrative penalties due to cross-compliance, including in the case of non-compliance directly attributable to the beneficiary concerned.

2 The [^{F5}appropriate authority may make regulations] laying down detailed procedural and technical rules concerning the calculation and application of administrative penalties referred to in Articles 97 to 99, including as regards beneficiaries consisting of a group of persons under Articles 28 and 29 of Regulation (EU) No 1305/2013.
