# Rules on cross-compliance

- The rules on cross-compliance shall consist of the statutory management requirements F2... and the standards for good agricultural and environmental condition of land established [F3 in the constituent nation] as listed in Annex II, relating to the following areas:
  - a environment, climate change and good agricultural condition of land;
  - b public, animal and plant health;
  - c animal welfare.
- The legal acts referred to in Annex II concerning the statutory management requirements shall apply in the version in force and, in the case of Directives, as implemented [F4 in the constituent nation].
