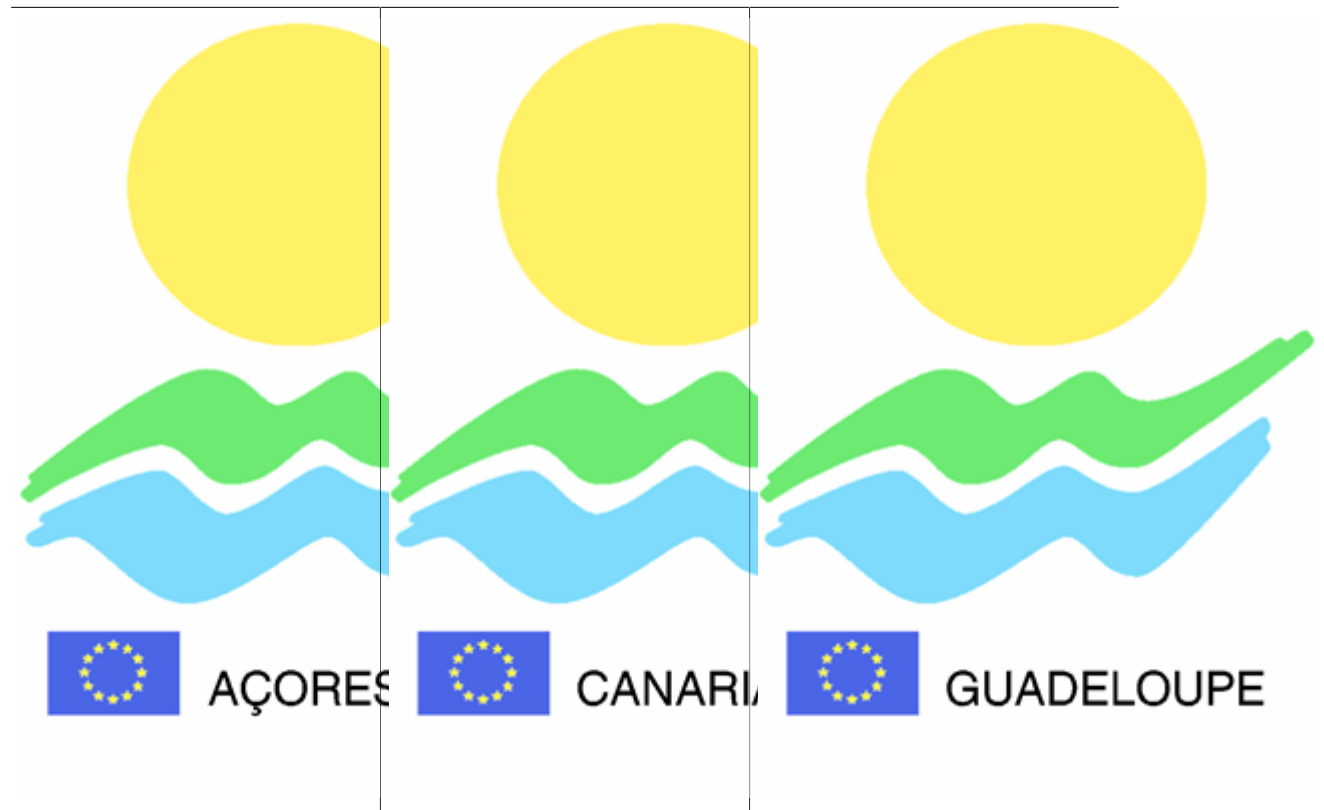

At the top of the Logo is a large, yellow sun giving warmth, light and growth to all life. 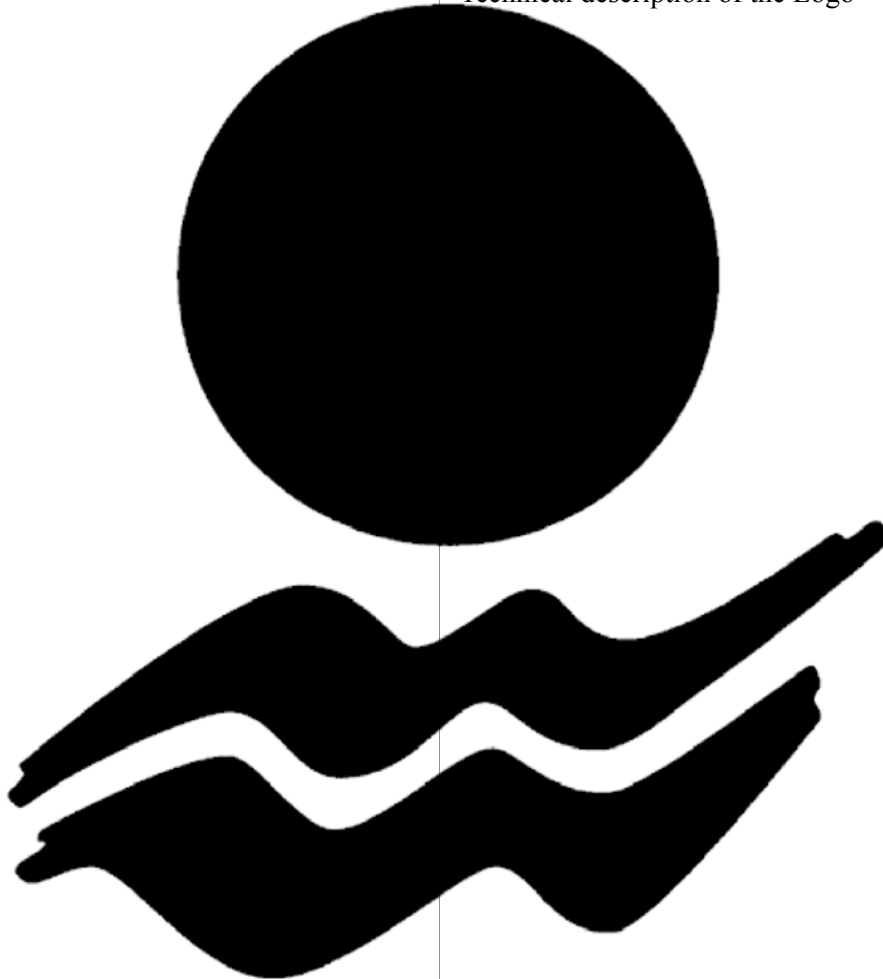
