Commission Regulation (EU) 2016/1004 of 22 June 2016 amending Regulation (EC) No 661/2009 of the European Parliament and of the Council (Text with EEA relevance)

Article 1

Annex IV to Regulation (EC) No 661/2009 is amended in accordance with the Annex to this Regulation.

Article 2

With effect from 1 July 2016, national authorities shall, on grounds relating to indirect vision, consider the certificates of conformity of new vehicles of categories N_2 and N_3 approved to Directive 2003/97/EC of the European Parliament and of the Council⁽¹⁾ to be no longer valid for the purposes of Article 26 of Directive 2007/46/EC, and shall prohibit the registration, sale and entry into service of such vehicles.

Article 3

With effect from 1 July 2016, national authorities shall, on grounds relating to their general construction, consider the certificates of conformity of new vehicles of categories M_2 and M_3 to be no longer valid for the purposes of Article 26 of Directive 2007/46/EC, and shall prohibit the registration, sale and entry into service of such vehicles where they do not comply with the provisions of UNECE Regulation No 107 as amended by the 05 series of amendments.

Article 4

With effect from 1 July 2016, national authorities shall, on grounds relating to the burning behaviour and/or the capability to repel fuel or lubricant of materials used in the construction, consider the certificates of conformity of new vehicles of category M₃ Classes II and III to be no longer valid for the purposes of Article 26 of Directive 2007/46/EC, and shall prohibit the registration, sale and entry into service of such vehicles where they do not comply with the provisions of UNECE Regulation No 118 as amended by the 01 series of amendments.

Article 5

This Regulation shall enter into force on the twentieth day following that of its publication in the *Official Journal of the European Union*.

It shall apply from 1 July 2016.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
