COMMISSION IMPLEMENTING REGULATION (EU) 2019/1346

of 8 August 2019

approving non-minor amendments to the specification for a name entered in the register of protected designations of origin and protected geographical indications ('Pomodoro S. Marzano dell'Agro Sarnese-Nocerino' (PDO))

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) No 1151/2012 of the European Parliament and of the Council of 21 November 2012 on quality schemes for agricultural products and foodstuffs (1), and in particular Article 52(2) thereof,

Whereas:

- (1) By virtue of the first subparagraph of Article 53(1) of Regulation (EU) No 1151/2012, the Commission has examined Italy's application for the approval of amendments to the specification for the protected designation of origin 'Pomodoro S. Marzano dell'Agro Sarnese-Nocerino', registered under Commission Regulation (EC) No 1263/96 (²), as amended by Commission Regulation (EU) No 1164/2010 (³). These amendments include changing the name 'Pomodoro S. Marzano dell'Agro Sarnese-Nocerino' to 'Pomodoro San Marzano dell'Agro Sarnese-Nocerino'.
- (2) Since the amendments in question are not minor within the meaning of Article 53(2) of Regulation (EU) No 1151/2012, the Commission published the amendment application in the Official Journal of the European Union (4) as required by Article 50(2)(a) of that Regulation.
- (3) As no statement of opposition under Article 51 of Regulation (EU) No 1151/2012 has been received by the Commission, the amendments to the specification should be approved,

HAS ADOPTED THIS REGULATION:

Article 1

The amendments to the specification published in the Official Journal of the European Union regarding the name 'Pomodoro S. Marzano dell'Agro Sarnese-Nocerino' (PDO) are hereby approved.

Article 2

This Regulation shall enter into force on the twentieth day following that of its publication in the Official Journal of the European Union.
