[^{F1} Article 11a

Suspension of entry into [^{F2}Great Britain]

1 [^{F3}Competent authorities] shall prohibit the entry into [^{F4}Great Britain] of the food and feed listed in Annex IIa.

2 Paragraph 1 shall apply to food and feed intended for placing on [^{F5}the market in Great Britain], and to food and feed intended for private use or consumption within [^{F6}Great Britain].]
