## Article 14

## List of third countries or regions thereof authorised for the entry into [FIGreat Britain] of gelatine and collagen

- [F2] Consignments of gelatine and collagen derived from bovine, ovine, caprine, porcine and equine animals, intended for human consumption shall only be authorised for the entry into [F3Great Britain] if they come from the third countries listed in column 1 of Part 1 of Annex II to Regulation (EU) No 206/2010 or from South Korea, Malaysia, Pakistan or Taiwan.
- Consignments of gelatine and collagen derived from poultry intended for human consumption shall only be authorised for the entry into [F3Great Britain] if they come from the third countries listed in column 1 of the table in Part 1 of Annex I to Regulation (EC) No 798/2008, or from Taiwan.]
- 3 Consignments of gelatine and collagen derived from fishery products intended for human consumption shall only be authorised for the entry into [F3Great Britain] if they come from the third countries or regions thereof that are listed in Annex II.
- Consignments of gelatine and collagen derived from leporidae and from wild land mammals others than ungulates intended for human consumption shall only be authorised for the entry into [F3Great Britain] if they come from the third countries F4... listed in column 1 of the table in Part 1 of Annex I to Regulation (EC) No 119/2009 [F5, or parts thereof specified by the Secretary of State, with the consent of the Scottish Ministers (in relation to Scotland) and the Welsh Ministers (in relation to Wales), under Article 3 of that Regulation in a document published for the purposes of that Article].
