

Commission Implementing Regulation (EU) 2019/947 of 24 May 2019 on the rules and procedures for the operation of unmanned aircraft (Text with EEA relevance)

*Article 19*

**Safety information**

1 The [F<sup>1</sup>CAA] and market surveillance and control authorities referred to in Article 36 of Delegated Regulation (EU) 2019/945 shall cooperate on safety matters and establish procedures for the efficient exchange of safety information.

2 Each UAS operator shall report to the [F<sup>2</sup>CAA] on any safety-related occurrence and exchange information regarding its UAS in compliance with Regulation (EU) No 376/2014.

3 The [F<sup>3</sup>CAA] shall collect, analyse and publish safety information concerning UAS operations<sup>F<sup>4</sup></sup>...

4 Upon receiving any of the information referred to in paragraphs 1 [F<sup>5</sup>or 2, the CAA] shall take the necessary measures to address any safety issues on the best available evidence and analysis, taking into account interdependencies between the different domains of aviation safety, and between aviation safety, cyber security and other technical domains of aviation regulation.

5 Where the [F<sup>6</sup>CAA] takes measures in accordance with paragraph 4, it shall immediately notify all relevant interested parties and organisations that need to comply with those measures in accordance with Regulation (EU) 2018/1139 and its implementing acts.
