#### Article 16

## **Prohibited species**

- 1 It shall be prohibited for [FIUnited Kingdom] fishing vessels to fish for, to retain on board, to tranship or to land the following species:

  - b leafscale gulper shark (*Centrophorus squamosus*) in [F³United Kingdom] waters of ICES division 2a and subarea 4 and in F⁴... international waters of ICES subareas 1 and 14;
  - c Portuguese dogfish (*Centroscymnus coelolepis*) in [F5United Kingdom] waters of ICES division 2a and subarea 4 and in F6... international waters of ICES subareas 1 and 14;
  - d kitefin shark (*Dalatias licha*) in [F7United Kingdom] waters of ICES division 2a and subarea 4 and in F8... international waters of ICES subareas 1 and 14;
  - birdbeak dogfish (*Deania calcea*) in [F9United Kingdom] waters of ICES division 2a and subarea 4 and in F10... international waters of ICES subareas 1 and 14;
