At the Court at Buckingham Palace, the 2nd day of August 1989 Present.

The Queen's Most Excellent Majesty in Council

Whereas a draft of this Order has been approved by a resolution of each House of Parliament:

Now, therefore, Her Majesty, in exercise of the powers conferred by paragraph 1 of Schedule 1 to the Northern Ireland Act 1974 1974 c. 28 and of all other powers enabling Her in that behalf, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:-

Title and commencement

1. This Order may be cited as the Appropriation (No. 2) (Northern Ireland) Order 1989 and shall come into operation forthwith.

Interpretation

2. The Interpretation Act (Northern Ireland) 1954 shall apply to 1954 c. 33 (N.I.) Article 1 and the following provisions of this Order as it applies to a Measure of the Northern Ireland Assembly.

Issue of sum out of the Consolidated Fund for year ending 31st March

3. The Department of Finance and Personnel may issue out of the Consolidated Fund and apply towards making good the supply granted to Her Majesty for the service of the year ending on 31st March 1990 the sum of two thousand, one hundred and ninety four million, eight hundred and ninety six thousand, nine hundred pounds.

THE APPROPRIATION (NO. 2) (NI) ORDER 1989 SI 1989/1336 (NI 8)

Power for Department of Finance and Personnel to borrow

- 4.—(1) Subject to paragraph (2), the Department of Finance and Personnel may borrow on the credit of the aforesaid sum, any sum or sums not exceeding in the whole one thousand and ninety seven million pounds.
- (2) Any money so borrowed shall be repaid, with any interest due thereon, out of the Consolidated Fund at any date not later than 31st March 1990.

Appropriation of grants

- 5.—(1) The sum granted by Article 3 out of the Consolidated Fund is appropriated for the several services and purposes specified in the Schedule.
- (2) In addition to the sum granted by Article 3 out of the Consolidated Fund, there may be applied as appropriations in aid of the grants for the several services and purposes specified in the Schedule the sums respectively specified in column 3.
