ADMINISTRATION AND ENFORCEMENT

Offences

Punishment of offences

36.—^{F1}(1) A person guilty of an offence under Article 34(1) shall be liable on summary conviction to a fine not exceeding level 5 on the standard scale or to imprisonment for a term not exceeding 3 months or to both.

^{F1}(2) A person guilty of any other offence under this Order shall be liable—

- (a) on conviction on indictment, to a fine or to imprisonment for a term not exceeding 2 years or to both;
- (b) on summary conviction, to a fine not exceeding the relevant amount or to imprisonment for a term not exceeding 6 months or to both.

^{F1}(3) In paragraph (2) “the relevant amount” means—

- (a) in the case of an offence under^{F2} Article 6 or 13], £20,000;
- (b) in any other case, the statutory maximum.
