Introductory

Restriction on institution of proceedings for certain offences

7.—^[F1(1)] Proceedings for an offence under Article 11(3) of the Order of 1981 (notice about relevant or prospective disability) shall not be instituted except by the Department or by a constable acting with the approval of the Department.

^[F1(2)] In paragraph (1) the reference to Article 11(3) of the Order of 1981 includes a reference to that provision as applied by Article 15D^[F2] or 19H] of that Order.]
