FOYLE FISHERIES**Foyle Area (Close Seasons for Angling) Regulations 1974**

REGULATIONS, DATED 10TH JANUARY 1974, MADE BY THE FOYLE FISHERIES COMMISSION WITH THE APPROVAL OF THE MINISTER FOR AGRICULTURE AND FISHERIES IN THE IRISH REPUBLIC UNDER SECTION 13 OF THE FOYLE FISHERIES ACT 1952¹ AND OF THE DEPARTMENT OF AGRICULTURE FOR NORTHERN IRELAND UNDER SECTION 13 OF THE FOYLE FISHERIES ACT (NORTHERN IRELAND) 1952.

The Foyle Fisheries Commission in exercise of its powers under section 13 of the Foyle Fisheries Act 1952, and section 13 of the Foyle Fisheries Act (Northern Ireland) 1952(a), hereby makes the following regulations:—

1. These regulations may be cited as the Foyle Area (Close Seasons for Angling) Regulations 1974 and shall come into force on the 1st day of March 1974.
2. The annual close seasons for angling for salmon and trout in the waters of the Foyle Area shall be as prescribed in the Schedule to these regulations.
3. The Foyle Area (Close Seasons for Angling) Regulations 1970(b), are hereby revoked.

SCHEDULE**Angling Close Seasons for the Waters of the Foyle Area**

- (a) THE RIVER FOYLE, LOUGH FOYLE, THE RIVER FINN, ITS LAKES AND TRIBUTARIES: the 16th day of September to the 13th day of March following, both days inclusive.
- (b) ALL REMAINING RIVERS IN THE FOYLE AREA: the 21st day of October to the 31st day of March following, both days inclusive.
- (c) ALL REMAINING LAKES OR LOUGHS IN THE FOYLE AREA: the 21st day of October to the last day of February following, both days inclusive.
