Lands Tribunal (Salaries) Order (Northern Ireland) 1974*Made* 19th August 1974*Coming into operation* 1st September 1974
*with effect in part from 1st January 1974**To be laid before Parliament under paragraph 3(3) of
Schedule 1 to the Northern Ireland Act 1974.*

The Secretary of State, in exercise of the powers conferred by section 2(5) of the Lands Tribunal and Compensation Act (Northern Ireland) 1964(a) and now vested in him by section 40 of and Schedule 5 to the Northern Ireland Constitution Act 1973(b) and of all other powers enabling him in that behalf hereby makes the following Order:—

Title and commencement

1. This Order may be cited as the Lands Tribunal (Salaries) Order (Northern Ireland) 1974 and shall come into operation on 1st September 1974.

Revocation

2. The Lands Tribunal (Salaries) (No. 2) Order (Northern Ireland) 1973(c) is hereby revoked.

Increase in salaries of members of the Lands Tribunal

3.—(1) The annual salary payable to the President of the Lands Tribunal shall be increased—

- (a) for the period 1st January 1974 to 31st May 1974 from £10550 to £10900;
- (b) for the period of June 1974 from £10900 to £10962.64;
- (c) for the period of July 1974 from £10962.64 to £11004.40;
- (d) for later periods from £11004.40 to £11025.28.

(2) The annual salary payable to any other Member of the Lands Tribunal shall be increased—

- (a) for the period 1st January 1974 to 31st May 1974 from £9900 to £10250;
- (b) for the period of June 1974 from £10250 to £10312.64;
- (c) for the period of July 1974 from £10312.64 to £10354.40;
- (d) for later periods from £10354.40 to £10375.28.

EXPLANATORY NOTE

(This note is not part of the Order, but is intended to indicate its general purport.)

This Order increases with effect from 1st January 1974 the salaries of the President of the Lands Tribunal for Northern Ireland from £10550 to £10900 and of each other member of the Tribunal from £9900 to £10250. The Order also increases those salaries with effect from June, July and August 1974 by the special supplements payable under paragraph 176 of the Counter-Inflation (Price and Pay Code) (No. 2) Order 1973.

The Order is made with retrospective effect in exercise of the power conferred by section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962 (which confers a general power to increase remuneration retrospectively).
