LIMITED PARTNERSHIPS

RULES, DATED 21ST OCTOBER 1974, MADE BY THE DEPARTMENT OF COM-MERCE UNDER SECTION 17 OF THE LIMITED PARTNERSHIPS ACT 1907.

The Department of Commerce, in exercise of the powers conferred upon it by section 17 of the Limited Partnerships Act 1907(a) and of all other powers enabling it in that behalf, with the consent of the Department of Finance as to fees, hereby makes the following Rules:—

Citation, commencement and revocation

- 1.—(1) These Rules may be cited as the Limited Partnerships Rules (Northern Ireland) 1974 and shall come into operation on 1st December 1974.
 - (2) The Limited Partnerships Rules 1907(b) are hereby revoked.

Interpretation

- 2.—(1) In these Rules "the 1907 Act" means the Limited Partnerships Act 1907.
- (2) The Interpretation Act (Northern Ireland) 1954(c) shall apply to the interpretation of these Rules as it applies to the interpretation of a Measure of the Assembly.

Forms

3. The forms in the Appendix hereto with such variations as the circumstances of each case may require shall be the forms to be used for the purposes of the 1907 Act.

Fees

- 4. The fees to be paid to the Registrar of Companies under the 1907 Act shall be as follows:—
 - (a) on the original registration of a limited partnership the sum of two pounds;
 - (b) on the registration of a statement of any change within the meaning of section 9(1) of the 1907 Act occurring during the continuance of a limited partnership the sum of 25p;
 - (c) by any person inspecting the statements filed by the Registrar the sum of 5p for each inspection;
 - (d) by any person requiring a certificate of registration of any limited partnership or a certified copy of or extract from any registered statement the sum of 10p for each certificate and for such certified copy or extract $2\frac{1}{2}$ p for each folio of seventy-two words.

Notes

- 1. Changes brought about by death, by transfer of interests, by increase in the number of partners, or by change of name of any partner, must be notified here.
- 2. If there is, or was, no definite term, then state against "previous term" the conditions under which the partnership was constituted and against "new term" the conditions under which it is now constituted.
- 3. Any variation in the sum contributed by any limited partner must be stated at (f) overleaf. A statement of any increase in the amount of the partnership capital, whether arising from increase of contributions, or from introduction of fresh partners, must also be made at (h) above. Capital duty is payable at £1 for every £100, or part of £100, on any increase in the amounts of contributions made in cash, or otherwise, by a limited partner.
- 4. Each change must be entered in the proper division (a), (b), (c), (d), (e), (f), (g) or (h), as the case may be. Provision is made in this form for notifying all the changes required by the Act to be notified, but it will frequently happen that only one item of change has to be notified. In any such case, the word "Nil" should be inserted in the other divisions.
- 5. The statement must be signed at the end by the firm, and delivered for registration within seven days of the change or changes taking place.
