Peripatetic and Supply Teachers

Regulations, dated 20th December 1974, made by the Department of Education under the Education and Libraries (Northern Ireland) Order 1972

The Department of Education (hereinafter referred to as "the Department") in pursuance of the powers vested in it by Articles 56, 57, 58 and 125 of the Education and Libraries (Northern Ireland) Order 1972(a) and by section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962(b) and of all other powers enabling it in that behalf, and after consultation with the Department of Finance, hereby makes the following regulations:

1.—(1) These regulations may be eited as the Peripatetic and Supply Teachers Amending Regulations (Northern Ireland) 1974, No. 2.

(2) Except as otherwise provided herein, these regulations shall be deemed to have come into operation on 1st April 1974.

2. For regulation 13 of the Peripatetic and Supply Teachers Regulations (Northern Ireland) 1973(c) there shall be substituted the following:

"13.--(1) The scales of salaries for teachers shall be the scales for assistant teachers, other than for vice-principals, second master/mistresses and senior teachers, as set out in the Salaries Regulations and the board shall determine in accordance with arrangements approved by the Department the scale to which each such teacher shall be appointed.

(2) The rates of remuneration of full-time unqualified teachers shall be the rates for unqualified teachers as set out in the Salaries Regulations.

(3) A teacher who is placed on scale 1 and who is employed for all his teaching duties as a teacher of special classes consisting mainly of handicapped pupils in a primary or secondary school or otherwise employed in teaching handicapped pupils may at the discretion of the board and with the approval of the Department receive in addition to his salary on scale 1 an allowance equal to the allowance payable to an assistant teacher in a special school under the Salaries Regulations.

(4) The following allowance, hereinafter referred to as the cost of living allowance, shall be payable to teachers and unqualified teachers in addition to salary as otherwise determined under these regulations:

- (a) The cost of living allowance shall be $\pounds 62.64$ per annum with effect from 1st June 1974; and
- (b) during the period up to and including 15th November 1974, for each additional 1.85 points increase above 202.1 in the Retail Price Index figure as published by the Department of Employment, the cost of living allowance shall be increased by £20.88 per annum with effect from the first day of the month next following the date of publication of such Retail Price Index figure.".

EXPLANATORY NOTE

(This note is not part of the regulations, but is intended to indicate their general purport.)

These regulations provide for the allowance payable to certain peripatetic and supply teachers of handicapped pupils to continue to be the same as the allowance payable to assistant teachers in a special school and for the payment of a cost of living allowance to peripatetic and supply teachers.
