LOCAL GOVERNMENT**Travelling and Subsistence Allowances to Councillors**

REGULATIONS, DATED 4TH MARCH 1974, MADE BY THE DEPARTMENT OF HOUSING, LOCAL GOVERNMENT AND PLANNING UNDER SECTION 36 OF THE LOCAL GOVERNMENT ACT (NORTHERN IRELAND) 1972 WITH THE APPROVAL OF THE DEPARTMENT OF FINANCE:

The Department of Housing, Local Government and Planning in exercise of the powers conferred on it by section 36 of the Local Government Act (Northern Ireland) 1972(a) and of every other power enabling it in that behalf and with the approval of the Department of Finance hereby makes the following Regulations:—

Citation

1. These Regulations may be cited as the Local Government (Travelling and Subsistence Allowances to Councillors) (Amendment) Regulations (Northern Ireland) 1974.

Increase in the rates of certain travelling allowances

2. In Schedule 1 to the Local Government (Travelling and Subsistence Allowances to Councillors) (No. 2) Regulations (Northern Ireland) 1973(b) (which prescribes the rates of travelling allowance payable to councillors of district councils) for sub-paragraphs (2)(a), (b) and (c) of paragraph 6 there shall be substituted the following:—

- “(a) for motor cars or tri-cars exceeding 1199 c.c. cylinder capacity: 7.8p a mile;
- (b) for motor cars or tri-cars exceeding 999 c.c. but not exceeding 1199 c.c. cylinder capacity: 6.9p a mile;
- (c) for motor cars or tri-cars exceeding 500 c.c. but not exceeding 999 c.c. cylinder capacity: 6.4p a mile;”

EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to indicate their general purport.)

These Regulations increase the rates of certain travelling allowances payable to councillors of district councils. The existing rates of such allowances are prescribed in the Local Government (Travelling and Subsistence Allowances to Councillors) (No. 2) Regulations (Northern Ireland) 1973 and only those rates relating to the use of a motor car or a tri-car are now amended.
