**HEALTH AND PERSONAL SOCIAL SERVICES****Health and Personal Social Services (Charges for Drugs and Appliances) (Amendment) Regulations (Northern Ireland) 1975**

*Made* . . . . . 25th June 1975

*Coming into operation* . . . . . 1st July 1975

The Department of Health and Social Services in exercise of the powers conferred on it by Articles 98, 106 and 107 of, and Schedule 15 to, the Health and Personal Social Services (Northern Ireland) Order 1972(a) and of all other powers enabling it in that behalf and with the approval of the Department of Finance hereby makes the following regulations:

*Citation and commencement*

1. These regulations may be cited as the Health and Personal Social Services (Charges for Drugs and Appliances) (Amendment) Regulations (Northern Ireland) 1975 and shall come into operation on 1st July 1975.

*Amendment of regulations*

2. In regulation 2(1) of the Health and Personal Social Services (Charges for Drugs and Appliances) Regulations (Northern Ireland) 1973(b)—

(1) after the definition "the Agency" there shall be inserted:

"“appliance” means an appliance, other than a contraceptive appliance, listed in Schedule 3 to the Health and Personal Social Services (General Medical and Pharmaceutical Services) Regulations (Northern Ireland) 1973(c) and conforming to any specification which may from time to time, be included in the Drug Tariff in respect of that appliance;”;

(2) for the definition "drugs" there shall be substituted—

"“drugs” includes, in the case of persons receiving general medical services, medicines, oxygen and any prescribed chemical reagents but does not include contraceptive substances;”;

(3) after the definition "drugs" there shall be inserted—

"“Drug Tariff” means the statement prepared by the Department under regulation 40 of the Health and Personal Social Services (General Medical and Pharmaceutical Services) Regulations (Northern Ireland) 1973;”.

#### EXPLANATORY NOTE

*(This note is not part of the regulations but is intended to indicate their general purport.)*

These regulations further amend the Health and Personal Social Services (Charges for Drugs and Appliances) Regulations (Northern Ireland) 1973 so that the charges for the making and recovery of which those regulations provide, shall not be made and recovered in respect of contraceptive substances and appliances.
