CORONERS

Coroners (Salaries) Rules (Northern Ireland) 1975

Made 4th August 1975

Coming into operation 31st August 1975

To be laid before Parliament

The Secretary of State(a) in pursuance of section 36(1)(a) of the Coroners Act (Northern Ireland) 1959(b) read with section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962(c), after consultation with the Minister for the Civil Service(d), hereby makes the following rules:

Citation and commencement

1.—(1) These rules may be cited as the Coroners (Salaries) Rules (Northern Ireland) 1975.

(2) These rules shall come into operation on 31st August 1975.

(3) Rules 2 and 3 shall have effect as from 1st July 1975 and rule 4 shall have effect as from 1st January 1975.

Salaries of coroners

2. The annual salary payable to a coroner appointed for a district set out in column 1 of the Schedule shall be the amount specified in column 2.

Salaries of deputy coroners

3. The annual salary payable to a deputy coroner shall be one-twelfth the annual salary prescribed by rule 2 of the coroner whose deputy he is.

Salary for coroner's officer for City of Belfast

4. The annual salary of the coroner's officer for the City of Belfast shall be:

£1,997 as from 1st January 1975;
£2,100 as from 1st April 1975.

Salaries to cover all expenses incurred by coroner, etc., in course of duties

5. The salaries payable under these rules shall be the only amounts payable to a coroner, deputy coroner or coroner's officer in respect of his duties as such and no amount shall be payable in addition to such salary for travelling, subsistence or other expenses incurred by him in the course of those duties.

EXPLANATORY NOTE

(This note is not part of the rules but is intended to indicate their general purport.)

These rules increase the salary rates for coroners and deputy coroners in Northern Ireland and the coroner's officer for the City of Belfast. Rules 2 and 3 have effect from 1st July 1975 and rule 4 has effect from 1st January 1975 by virtue of section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962.
