The Department of Housing, Local Government and Planning(a) (in this Order referred to as "the Department") with the approval of the Department of Finance(b), in exercise of the powers conferred on the Department by section 1 of the Housing (No. 2) Act (Northern Ireland) 1946(c) and of every other power enabling it in that behalf, hereby makes the following Order:

1. This Order may be cited as the Housing Subsidy (Variation) (No. 3) Order (Northern Ireland) 1975 and shall be construed as one with the Housing Subsidy Order (Northern Ireland) 1962(d) and shall come into operation on 16th September 1975.

2. In its application to a housing scheme in respect of which the tender has been submitted for approval to the Department by the Northern Ireland Housing Executive(e) or accepted by a housing association after 15th September 1975, the Housing Subsidy Order (Northern Ireland) 1962 shall be amended by substituting for the Schedule therein the Schedule to this Order.
