1. This Order may be cited as the Local Government (Modifications and Repeals of Historic Monuments Legislation) Order (Northern Ireland) 1976 and shall come into operation on 10th May 1976.

2. The transferred provisions mentioned in columns 1 to 3 of the Schedule shall have effect subject to the modifications and repeals specified in column 4.
