# Colleges of Education (Grant Conditions) (Amendment) Regulations (Northern Ireland) 1976

The Department(a) of Education, in exercise of the powers conferred on it by Articles 55 and 125 of the Education and Libraries (Northern Ireland) Order 1972(b) and of every other power enabling it in that behalf hereby makes the following regulations:

#### Citation and commencement

1. The regulations may be cited as the Colleges of Education (Grant Conditions) (Amendment) Regulations (Northern Ireland) 1976 and shall come into operation on 1st July 1976.

#### Increase of grants

2.-(1) Subject to paragraph (2), in regulation 13(1)(a) of the Training Colleges (Grant Conditions) Regulations 1956(c) as substituted by regulation 3 of the Colleges of Education (Grant Conditions) Amending Regulations (Northern Ireland) 1968(d) for "eighty" there shall be substituted "eightyfive".

(2) Paragraph (1) shall apply only in relation to grant on expenditure incurred in respect of-

- (a) the provision or alteration of premises the work on which commences; and
- (b) the provision of equipment the expenditure for which is approved, on or after 1st July 1976.

#### Amendment

3.-(1) In regulation 13(1) of the Training Colleges (Grant Conditions) Regulations 1956 as substituted by regulation 3 of the Colleges of Education (Grant Conditions) Amending Regulations (Northern Ireland) 1968 there shall be added after sub-paragraph 13(1)(b):---

"(c) the Department may pay grant towards the purchase price or so much thereof as the Department may approve of any land or premises purchased for the erection of a new voluntary college or the extension of an existing voluntary college."

(2) In regulation 13 of the Training Colleges (Grant Conditions) Regulations 1956 substituted by regulation 3 of the Colleges of Education (Grant Conditions) Amending Regulations (Northern Ireland) 1968 for paragraph (5) there shall be substituted :-

"(5) Any grants payable under these regulations may be paid by such instalments as the Department may think proper."

# EXPLANATORY NOTE
