Article 2

AMENDMENTS

1. In Article 4(7) of the Agricultural Development Loans (Livestock) Scheme (Northern Ireland) 1962(d) for "two thousand pounds" substitute "£5,000".

2. In Article 4(4) of the Agricultural Development Loans (Seeds and Fertilisers) Scheme (Northern Ireland) 1962(e) for "two thousand pounds" substitute "£5,000".

3. In Article 4(7) of the Agricultural Development Loans (Byre and Dairy) Scheme (Northern Ireland) 1962(f) for "two thousand pounds" substitute "£7,000".

4. In Article 4(5) of the Agricultural Development Loans (Farm Dwellings) Scheme (Northern Ireland) 1962(g) for "two thousand five hundred pounds" substitute "£7,000".

5. In Article 4(6) of the Agricultural Development Loans (Small Agricultural Industries) Scheme (Northern Ireland) 1962(h) for "three thousand pounds" substitute "£5,000".

6. In Article 4(5) of the Agricultural Development Loans (Private Woodlands) Scheme (Northern Ireland) 1962(i) for "two thousand pounds" substitute "£5,000".

7. In Article 4(5) of the Agricultural Development Loans (Electrical Plant and Machinery) Scheme (Northern Ireland) 1962(j) for "two thousand pounds" substitute "£5,000".

8. In Article 4(5) of the Agricultural Development Loans (Farm Structures) Scheme (Northern Ireland) 1963(k) for "two thousand pounds" substitute "£7,000".

9. In Article 3(4) of the Agricultural Development Loans (Agricultural Shows) Scheme (Northern Ireland) 1965(1) for "three thousand pounds" substitute "£5,000".

10. In Article 5(1) of the Agricultural Development Loans (Machinery and Equipment) (Hire Purchase) Scheme (Northern Ireland) 1967(m) for "two thousand pounds "substitute "£5,000".

11. For Article 4 of the Agricultural Development Loans (Amalgamations) Scheme (Northern Ireland) 1967(n) there shall be substituted the following Article:

"4—(1) The amount of any loan made under this Scheme shall not exceed $\pm 10,000$ except with the special sanction of the Department of Finance.

(2) Security for any loan shall be such as may be required by the Department and the rate of interest thereon shall be such as may be determined by the Department of Finance.

EXPLANATORY NOTE

(This note is not part of the Scheme but is intended to indicate its general purport.)

This Scheme amends certain Schemes, made under the Development Loans (Agriculture and Fisheries) Act (Northern Ireland) 1968, to increase the size of the loans which may be made by the Department, without reference to the Department of Finance. The Scheme also revokes the Agricultural Development Loans (Amendment) Scheme (Northern Ireland) 1975.
