Housing Subsidy (Variation) (No. 3) Order (Northern Ireland) 1976

Made 15th September 1976 Coming into operation . 16th September 1976

The Department of the Environment for Northern Ireland (in this Order referred to as "the Department") with the approval of the Department of Finance(a), in exercise of the powers conferred by Section 1 of the Housing (No. 2) Act (Northern Ireland) 1946(b) and now vested in it(c) and of every other power enabling it in that behalf hereby makes the following Order:

- 1. This Order may be cited as the Housing Subsidy (Variation) (No. 3) Order (Northern Ireland) 1976 and shall be construed as one with the Housing Subsidy Order (Northern Ireland) 1976(d) and shall come into operation on 16th September 1976.
- 2. In its application to a housing scheme in respect of which the tender has been submitted for approval to the Department by the Northern Ireland Housing Executive(e) or accepted by a housing association after 15th September 1976, the Housing Subsidy Order (Northern Ireland) 1976 shall be amended by substituting for the Schedule therein the Schedule to this Order.
