HOUSING ON FARMS**Housing on Farms (Grants) Order (Northern Ireland) 1976***Made* 6th October 1976*Coming into operation* 1st January 1977*To be laid before Parliament under paragraph 3(3) of
Schedule 1 to the Northern Ireland Act 1974*

The Department of the Environment for Northern Ireland (in this Order referred to as "the Department") with the approval of the Department(a) of Finance in exercise of the powers conferred by section 11 of the Housing on Farms Act (Northern Ireland) 1972(b) (in this Order referred to as "the Act") and now vested in it(c) and of every other power enabling it in that behalf hereby makes the following Order:—

Citation and commencement

1. This Order may be cited as the Housing on Farms (Grants) Order (Northern Ireland) 1976 and shall come into operation on 1st January 1977.

Grants for provision of new farmhouses

2. The amount of grant payable under section 1 of the Act in respect of the provision of a new farmhouse completed between 1st January 1977 and 31st December 1977 inclusive in accordance with plans approved by the Department, and falling within the category mentioned in the first column of Schedule 1, shall be the amount specified in the second column of the said Schedule.

Grants for provision of houses for approved workers

3. The amount of grant payable under section 4 of the Act in respect of the provision of an approved worker's house completed between 1st January 1977 and 31st December 1977 inclusive in accordance with plans approved by the Department, and falling within the category mentioned in the first column of Schedule 2, shall be the amount specified in the second column of the said Schedule.

EXPLANATORY NOTE

(This note is not part of the Order but is intended to indicate its general purport.)

This Order continues the existing rates of grant for the provision of new farmhouses and houses for approved workers which are completed during the year 1977.
