The Department of Agriculture in exercise of the powers conferred on it by Section 1 of the Agriculture (Temporary Assistance) Act (Northern Ireland) 1954(a) as amended by the Agriculture (Temporary Assistance) (Amendment) Act (Northern Ireland) 1957(b) and now vested in it(c) and of every other power enabling it in that behalf and with the approval of the Department of Finance(d) hereby makes the following Scheme:

Citation and commencement

1. This Scheme may be cited as the Pigs (Feed Price Allowance) (Amendment No. 2) Scheme (Northern Ireland) 1976 and shall come into operation on 1st November 1976.

Amendment of Scheme

- 2. The Pigs (Feed Price Allowance) Scheme (Northern Ireland) 1972(e) as amended(f) is hereby further amended as follows:-
 - (1) In article 2 after the definition of "Board" there shall be inserted "eligible pig" means either a pig born and reared in Northern Ireland or one which has been imported to Northern Ireland and retained there for at least six weeks prior to its slaughter.
 - (2) In article 4 for the words "pig produced in Northern Ireland and" there shall be substituted the words "eligible pig".
