# Motor Cars (Driving Instruction) (Amendment) Regulations (Northern Ireland) 1976

27th October 1976 Made Coming into operation 1st December 1976

The Department of the Environment for Northern Ireland in exercise of the powers conferred by sections 117, 117C and 189 of the Road Traffic Act (Northern Ireland) 1970(a) and now vested in it(b) and of every power enabling it in that behalf hereby makes the following Regulations:

#### Citation and commencement

1. These Regulations may be cited as the Motor Cars (Driving Instruction) (Amendment) Regulations (Northern Ireland) 1976 and shall come into operation on 1st December 1976.

### Regulations amended

2. The Motor Cars (Driving Instruction) Regulations (Northern Ireland) 1974(c) shall be amended as follows:

In regulation 18—

- (a) in paragraph (1) for "£5" there shall be substituted "£15";
- (b) in paragraph (2) for "£10" there shall be substituted "£25";
- (c) in paragraph (3) for "£15" there shall be substituted "£25";
- (d) in paragraph (4) for "£15" there shall be substituted "£25";
- (e) in paragraph (5) for "£15" there shall be substituted "£25"; and
- (f) in paragraph (6) for "£1" there shall be substituted "£15".

#### EXPLANATORY NOTE

(This note is not part of the regulations but is intended to indicate their general purport.)

These regulations amend the Motor Cars (Driving Instruction) Regulations (Northern Ireland) 1974 by increasing the fees for:

- (a) the written part of the examination of ability to give instruction from £5 to £15;
- (b) the practical part of the examination of ability to give instruction from £10 to £25;
- (c) an application for retention on the Register from £15 to £25;
- (d) an application for entry on the Register by a person on the corresponding Register in Great Britain from £15 to £25;
- (e) an application for re-entry on the Register in the circumstances described in regulation 18(5) of the Regulations of 1974 from £15 to £25;
  and
- (f) an application for a licence to give instruction from £1 to £15.
