## Poisons List (Amendment) Order (Northern Ireland) 1976

Made . . . . . 18th November 1976

Coming into operation . . . . . 3rd January 1977

The Department of Health and Social Services on the recommendation of the Poisons Board, constituted in accordance with section 26 of the Medicines, Pharmacy and Poisons Act (Northern Ireland) 1945(a), and in exercise of the powers conferred on it by section 26A(6) of the Medicines, Pharmacy and Poisons Act (Northern Ireland) 1945 and now vested in it(b) and of every other power enabling it in that behalf hereby makes the following Order:

*Citation and Commencement*

1. This Order may be cited as the Poisons List (Amendment) Order (Northern Ireland) 1976 and shall come into operation on 3rd January 1977.

*Amendments*

2. The "Poisons Schedule"(c) set out in the Poisons List Order (Northern Ireland) 1974(d) shall be amended by inserting in Schedule 2—

- (a) in Part I, after the item beginning with the word "Alphaprodine" there shall be inserted the item "Aluminium Phosphide" and after the item "Chloroform" there shall be inserted the item "Chloropicrin";
- (b) in Part II, after the item beginning with the word "Diamines" there shall be inserted the item " $\beta$ -[2-(3, 5-Dimethyl-2-oxocyclohexyl)-2-hydroxyethyl] glutarimide", in the item beginning with the word "Phosphorous", after the word "mecarbam" there shall be inserted the word "methidathion" and after the word "phosphamidon" there shall be inserted the word "pirimiphos-ethyl".

## EXPLANATORY NOTE

*(This note is not part of the Order, but is intended to indicate its general purport.)*

This Order amends the Poisons Schedule by adding Aluminium phosphide and Chloropicrin to Part I and by adding  $\beta$ -[2-(3,5-Dimethyl-2-oxocyclohexyl)-2-hydroxyethyl] glutarimide (commonly known as Cycloheximide) and the phosphorous compounds Methidathion and Pirimiphos-Ethyl to Part II.
