LEGAL AID AND ADVICE

Legal Advice (Assessment of Resources) Regulations (Northern Ireland) 1976

Made 17th November 1976 15th December 1976 Coming into operation .

To be laid before Parliament

The Secretary of State(a) in pursuance of section 7 of the Legal Aid and Advice Act (Northern Ireland) 1965(b) hereby makes the following regulations:

Citation, commencement and interpretation

- 1.—(1) These regulations may be cited as the Legal Advice (Assessment of Resources) Regulations (Northern Ireland) 1976 and shall come into operation on 15th December 1976.
 - (2) In these regulations—

"the Act" means the Legal Aid and Advice Act (Northern Ireland) 1965; "the Regulations of 1970" means the Legal Advice Regulations (Northern Ireland) 1970(c);

"the Regulations of 1975" means the Legal Advice (Assessment of Resources) Regulations (Northern Ireland) 1975(d).

Assessment of resources

- 2. For paragraph (4)(a), (b) and (c) of regulation 3 of the Regulations of 1970 as substituted by regulation 2 of the Regulations of 1975 there shall be substituted the following provisions:
 - "(4) The deductions to be made from the income of an applicant shall he-
 - (a) £7.95 in respect of any spouse of his if wholly or substantially maintained by him, or where the capital and income of the spouse are treated as his resources;
 - (b) in respect of any child wholly or substantially maintained by him, or by any spouse of his where the capital and income of the spouse are treated as his resources-

where the child is under five years of age . £3.60 where the child is five or more years of age but under eleven years of age . £4.35 where the child is eleven or more years of age but under thirteen years of age £5.35
