PROCEDURE

Rules of the Supreme Court (Northern Ireland) (No. 3) 1976

Made 27th October 1976

Coming into operation 3rd January 1977

To be laid before Parliament

We, the Northern Ireland Supreme Court Rules Committee, being the authority having for the time being power under section 7 of the Northern Ireland Act 1962(a) to make, amend or revoke rules regulating the practice and procedure of the Supreme Court of Judicature of Northern Ireland, hereby with the concurrence of the Treasury, so far as is required by subsection (4) of that section, exercise those powers and all other powers enabling us in that behalf as follows:

1. In Scale I of Part VI of Appendix S of the Rules of the Supreme Court (Northern Ireland) 1936(b) for the figures "£15.50", "£16.50", "£17.50", "£19.75" and "£23.75" there shall be substituted the figures "£24.50", "£25.50", "£26.50", "£28.75" and "£32.75" respectively.

2. In Scale II of Part VI of Appendix S for the figures "£17.00", "£18.00", "£19.00", "£24.00" and "£28.00" there shall be substituted the figures "£28.75", "£29.75", "£30.75", "£35.75" and "£39.75" respectively.

3. Scale III of Part VI of Appendix S shall be amended as follows:

- (a) in paragraph 8 for the figures "£2.10" there shall be substituted the figures "£3.80";
- (b) in paragraph 9 for the figures "£3.15" and "£9.45" there shall be substituted the figures "£4.75" and "£11.00" respectively;
- (c) in paragraph 10 for the figures "£1.75" and "£2.50" there shall be substituted the figures "£3.45" and "£4.20" respectively.

4. These rules may be cited as the Rules of the Supreme Court (Northern Ireland) (No. 3) 1976 and shall come into operation on 3rd January 1977.

EXPLANATORY NOTE

*(This note is not part of the Rules but is intended to indicate
their general purport.)*

These rules amend Appendix S of the Rules of the Supreme Court (Northern Ireland) 1936.

The fixed costs in Scales I, II and III of Part VI of Appendix S are increased to cover additional outlay consequent upon the increase in court fees in the Supreme Court Fees Order (Northern Ireland) 1976.
