ROAD TRAFFIC AND VEHICLES

Off-Street Parking (Amendment) (No. 2) Bye-laws
(Northern Ireland) 1977

Made 10th May 1977

Coming into operation 30th May 1977

The Department of the Environment for Northern Ireland in exercise of the powers conferred by section 89 of the Road Traffic Act (Northern Ireland) 1970(a) and now vested in it(b) and all other powers enabling it in that behalf hereby makes the following Bye-laws:—

Citation and commencement

1. These Bye-laws may be cited as the Off-Street Parking (Amendment) (No. 2) Bye-laws (Northern Ireland) 1977 and shall come into operation on 30th May 1977.

Revocation

2. The Bye-laws specified in Schedule 3 are hereby revoked.

Bye-laws amended

3. The Off-Street Parking Bye-laws (Northern Ireland) 1976(c) shall be amended as follows:—

(a) by the addition to Schedule 1 Part I of the car parks included in Schedule 1; and

(b) by the addition to Schedule 1 Part II of the tariffs included in Schedule 2.
