Employment in Agriculture (Amendment) Scheme (Northern Ireland) 1977

Made 31st May 1977 Coming into operation 21st June 1977

The Department of Agriculture in exercise of the powers conferred on it by section 1 of the Agriculture (Temporary Assistance) Act (Northern Ireland) 1954(a) as amended by the Agriculture (Temporary Assistance) (Amendment) Act (Northern Ireland) 1957(b) and now vested in it(c) and of every other power enabling it in that behalf, and with the approval of the Department(c) of Finance, hereby makes the following Scheme:

Citation and commencement

- 1.—(1) This Scheme may be cited as the Employment in Agriculture (Amendment) Scheme (Northern Ireland) 1977.
- (2) The Employment in Agriculture (Northern Ireland) Schemes 1972-1976(d) and this Scheme may together be cited as the Employment in Agriculture (Northern Ireland) Schemes 1972-1977.
 - (3) This Scheme shall come into operation on 21st June 1977.

Amendment of Schemes

- 2.—(1) For paragraph (2) of article 1 of the Employment in Agriculture (Amendment) Scheme (Northern Ireland) 1976(e) there shall be substituted the following paragraph:
 - (2) The Employment in Agriculture (Northern Ireland) Schemes 1972-75 and this Scheme may together be cited as the Employment in Agriculture (Northern Ireland) Schemes 1972-1976."
- (2) In article 5(3) of the Employment in Agriculture (Northern Ireland) Scheme 1972(f) for "£25,000,000" there shall be substituted "£40,000,000".
