College of Education Salaries (Amendment) Regulations (Northern Ireland) 1977

Made 16th June 1977 29th June 1977 Coming into operation

The Department(a) of Education in exercise of the powers conferred on it by articles 57 and 125 of the Education and Libraries (Northern Ireland) Order 1972(b) and by section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962(c) and of every other power enabling it in that behalf, and after consultation with the Department of Finance(a), hereby makes the following regulations:

Citation and commencement

1. These regulations may be cited as the College of Education Salaries (Amendment) Regulations (Northern Ireland) 1977 and shall come into operation on 29th June, 1977, and shall have effect from 1st April, 1977.

Regulations revoked

2. The College of Education Salaries (Amendment) Regulations (Northern Ireland) 1976(d) are hereby revoked.

Amendment

- 3. The College of Education Salaries Regulations (Northern Ireland) 1975(e) are hereby amended as follows:
 - (a) After regulation 8(2) there shall be added:

"SALARY SUPPLEMENT

Definition

9. For the purposes of regulations 9A, 9B, 9C and 10 "remuneration" in relation to any person, includes any benefit, facility or advantage, whether in money or otherwise, provided by the employer or by some other person under arrangements with the employer, whether for the first mentioned person or otherwise, by reason of the fact that the employer employs him, and any reference to the payment of remuneration shall be construed accordingly.

Increase in remuneration

9A.—(1) A full-time teacher whose remuneration does not exceed £8,500 per annum shall receive an additional payment at the rate of £312 per annum, save that if such payment would increase his remuneration beyond £8,500 per annum he shall be paid only such sum as will increase his rate of remuneration to that amount.

(2) Entitlement to the additional payment under paragraph (1) shall be reassessed in accordance with the provisions of that paragraph whenever there is any change in the remuneration (apart from the said additional payment and the addition to remuneration payable under the provisions of regulation 9B) payable to a teacher under these regulations, provided that no reassessment shall be made by reason of a teacher becoming eligible for an annual increment except such reassessment as may be necessary to secure that his total remuneration after payment of the increment shall not exceed what it would have been had he been in receipt of salary at the maximum of his scale.

Additions to remuneration effective from 1st April 1977

- 9B. A full-time teacher shall receive an addition to remuneration determined as follows:
 - (a) if his remuneration is less than £3,200 per annum—an addition of £132 per annum;
 - (b) if his remuneration is £4,160 or more per annum an addition of £180 per annum;
 - (c) in all other cases the addition shall be an amount per annum equal to £28 less than 5 per cent. of his annual remuneration, such amount being calculated to the nearest multiple of £3, a remainder of £1.50 being treated for the purpose of this calculation as being nearer to the next higher multiple of £3.
 - **9C.** Any payment made under regulation 9A, 9B and any like payment made to a teacher as part of his remuneration for teaching service in a recognised school, institution of further education, college of education or the Ulster College shall be disregarded for the purposes of determining the salary placing position of a teacher on any of the scales set out in these regulations.".
 - (b) For regulation 10 there shall be substituted:

"PART-TIME TEACHERS

10. Teachers employed in regular part-time service shall be paid a proportion of the annual salary and additional payments under regulations 9A and 9B that would be appropriate if they were employed full-time. The proportion shall correspond to the proportion of full-time service that the college authority deems the teacher to be employed.".

EXPLANATORY NOTE

(This note is not part of the regulations, but is intended to indicate their general purport.)

These regulations revoke the College of Education Salaries (Amendment) Regulations (Northern Ireland) 1976 and amend the College of Education Salaries Regulations (Northern Ireland) 1975. The regulations provide for an addition to remuneration, within the terms of the Pay Policy, payable with effect from 1st April, 1977, to teachers in colleges of education.

Regulation 9A continues the provisions for the payment of the increase in remuneration (normally £312 per annum subject to a maximum total remuneration of £8,500 per annum) that was awarded with effect from 1st April, 1976. The regulations have retrospective effect by virtue of section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962.
