Bovine Leucosis Order (Northern Ireland) 1977

Made 14th February 1977 1st March 1977 Coming into operation

The Department(a) of Agriculture, in exercise of the powers conferred on it by sections 4, 5, 7, 8, 13, 14 and 53 of the Diseases of Animals Act (Northern Ireland) 1958(b) (hereinafter referred to as "the Act"), and of every other power enabling it in that behalf, hereby makes the following Order:

Citation and commencement

1. This Order may be cited as the Bovine Leucosis Order (Northern Ireland) 1977 and shall come into operation on 1st March 1977.

Interpretation

- 2. In this Order—
- "animal" means a live bovine animal;
- "approved disinfectant" means a disinfectant for the time being approved by the Department under the Diseases of Animals (Approval of Disinfectants) Order (Northern Ireland) 1972(c) for the purposes of general Orders:
- "authorised" means authorised by the Department;
- "carcase" means the carcase of an animal and includes part of a carcase and the meat, bones, hide, skin, hair, hooves, horns, offal or other part of an animal, separately or otherwise, or any portion thereof;
- "Department" means the Department of Agriculture;
- "disease" means bovine leucosis;
- "diseased" means affected with bovine leucosis:
- "Divisional Veterinary Officer" means a Divisional Veterinary Officer of the Department;
- "infected place" means any land or premises declared by a veterinary inspector to be an infected place in accordance with Article 5;
- "suspected" means suspected of being diseased;
- "veterinary inspector" means a person appointed by the Department to be an inspector for the purposes of the Act, being either a member of the Royal College of Veterinary Surgeons or a veterinary practitioner qualified as approved by the Department;
- "veterinary research laboratory" means the Veterinary Research Laboratory, Stormont, Belfast, or the Veterinary Investigation Laboratory, Omagh.

Notification of disease and isolation of animals and carcases

3.—(1) The provisions of section 4 of the Act shall be varied in the manner provided in paragraphs (2), (3), (4), (5) and (7).

- (2) Every person having in his possession or under his charge an animal or carcase which is diseased or suspected shall with all practicable speed give notice of the fact to a Divisional Veterinary Officer.
- (3) Any person who examines or handles any animal or carcase on any land or premises and suspects that the animal or carcase is diseased shall, with all practicable speed, give notice of the fact to a Divisional Veterinary Officer.
- (4) Where a veterinary surgeon or veterinary inspector carries out an examination of an animal or carcase and suspects that it is diseased he shall, in addition to giving notice to a Divisional Veterinary Officer, take such samples from the animal or carcase as may be necessary for diagnostic purposes, and shall forward them forthwith to a veterinary research laboratory together with a report on his examination of the animal or carcase.
- (5) A notice required to be given under this Article shall include the ear number and description of the animal concerned and the name and address of the owner.
- (6) A Divisional Veterinary Officer on receiving notice of a diseased or suspected animal or carcase shall, except where the notice is received from a veterinary surgeon or veterinary inspector, arrange for samples to be taken from the animal or carcase for diagnostic purposes.
- (7) Where notice is given to a Divisional Veterinary Officer under this Article, the animal or carcase concerned shall be isolated by the owner or person in charge of it from all other animals and carcases on the premises until a notice is served under Article 4 or an alternative direction is given by the Divisional Veterinary Officer.

Isolation and prohibition of movement

- 4.—(1) Where a Divisional Veterinary Officer receives information under the preceding Article, or from any other source, that an animal or carcase is diseased or suspected, he may cause a notice in the Form A prescribed in Schedule 1 to be served on the owner or person in charge of the animal or carcase.
 - (2) On service of such notice in the Form A-
 - (a) the animal or carcase referred to therein shall be isolated and detained on the premises specified in the notice, and the said animal or carcase and any other animal or carcase, and any litter or dung which has or may have been in contact with the said animal or carcase, shall not be moved from the premises except under and in accordance with a licence granted by a veterinary inspector; and
 - (b) no vehicle, machinery or equipment which has or may have been in contact with any animal or carcase, litter or dung described in the preceding sub-paragraph, shall be moved from the premises until such vehicle, machinery or equipment has been thoroughly washed, cleansed and disinfected with an approved disinfectant.
- (3) The restrictions imposed by a notice served under this Article shall remain in force until withdrawn by a further notice in the Form B prescribed in Schedule 1.

Declaration of infected place

5.—(1) Where, as the result of laboratory tests carried out on an animal or carcase, disease is confirmed on any premises, a veterinary inspector may serve a notice in the Form C prescribed in Schedule 1 on the owner, occupier or person in charge of such premises declaring them to be an infected place for the purposes of the Act.

- (2) Immediately on service of such notice the premises shall become an infected place within the limits specified by the notice and shall be subject to the Rules prescribed in Schedule 2.
- (3) A veterinary inspector may serve a notice on the owner, occupier or person in charge of an infected place—
 - (a) altering the limits of the infected place;
 - (b) directing that any of the Rules prescribed in Schedule 2 shall cease to apply to the infected place or shall be modified to the extent or in the manner specified in the notice; or
 - (c) directing that such additional Rules as may be specified in the notice shall apply to the infected place.
- (4) A notice served in accordance with paragraph (1) or (3) shall remain in force until withdrawn by a further notice in the Form D prescribed in Schedule 1.

Marking

6. An authorised officer may paint, stamp or clip any mark on any animal or may permanently mark an animal. No person shall remove, obliterate, deface or duplicate or attempt to remove, obliterate, deface or duplicate such a mark.

Cleansing and disinfection

- 7. An inspector may serve a notice on the owner or occupier of any place on which a diseased animal or carcase is or was kept requiring him at his own expense to carry out cleansing and disinfection as follows—
 - (a) all parts of any building or other area in which such animal or carcase is or was kept shall be thoroughly soaked with an approved disinfectant;
 - (b) the same parts of the building or other area shall then be thoroughly scraped and swept and all scrapings and sweepings and all manure, litter and other matter shall be removed;
 - (c) the same parts of the building or other area shall again be thoroughly disinfected with an approved disinfectant;
 - (d) all scrapings, sweepings, manure, litter and other matter shall be removed from the place and shall forthwith be buried or effectually destroyed;
 - (e) all vehicles, machinery, utensils, pens, hurdles, equipment or other thing used for or about the diseased animal or carcase shall be thoroughly cleansed and disinfected with an approved disinfectant.

Offences

8. It shall be unlawful for any person to fail to comply with the provisions of this Order or the Rules prescribed in Schedule 2.

(b) any vehicle, machinery or equipment which has or may have been in contact with any animal/carcase, litter or dung described in the preceding paragraph, shall not be moved from the premises until such vehicle machinery or equipment has been thoroughly washed, cleansed and disinfected with an approved disinfectant.		
This notice remains in force until withdrawn by a subsequent notice in the Form B.

Any person who fails to comply with the Rules of an infected place shall be guilty of an offence against the Diseases of Animals Act (Northern Ireland) 1958 and subject to the penalties imposed by that Act.		
This notice remains in force until withdrawn by a subsequent notice (Form D) served by a veterinary inspector of the Department on the owner, occupier or person in charge of the infected place. Signed

SCHEDULE 2

Article 5

Rules applicable to infected place

- 1. No animal, carcase, litter or dung shall be moved out of an infected place except in accordance with the conditions of a licence granted by a veterinary inspector.
- 2. No vehicle, machinery or equipment which has been in contact with a diseased animal or carcase, or with anything used for or about a diseased animal or carcase, shall be moved out of an infected place until such vehicle, machinery or equipment has been thoroughly washed, cleansed and disinfected with an approved disinfectant.
- 3. Any vehicle, machinery or equipment used for moving a diseased animal or carcase shall, immediately after such movement, be thoroughly cleansed and disinfected with an approved disinfectant.
- 4. The owner, occupier or person in charge of an infected place shall comply with such requirements regarding isolation and segregation of stock on the premises as may, in the opinion of an inspector, be necessary to prevent the spread of disease.
- 5. All litter, dung, liquid manure, equipment or other thing shall be treated or disposed of as an inspector may direct.
- 6. The owner, occupier or person in charge of an infected place shall carry out cleansing and disinfection as required by Article 7 and shall comply with such further requirements in respect of cleansing and disinfection as may, in the opinion of an inspector, be necessary to control the spread of disease. If the owner, occupier or person in charge fails to comply with such requirements the Department, without prejudice to the recovery of any penalty for infringement of these Rules, may carry out the required cleansing and disinfection, and the expense thereof may be recovered summarily by the Department from the owner, occupier or person in charge of the infected place.

EXPLANATORY NOTE

(This note is not part of the Order but is intended to indicate its general purport.)

This Order enables the Department to deal with cases, or suspected cases, of bovine leucosis and to take measures to prevent the spreading of the disease.

Any person who has in his possession, or under his charge, a diseased or suspect animal or carcase must notify a Divisional Veterinary Officer without delay. Likewise a person who handles a suspect animal or carcase on any land or premises (such as an abattoir, knackery, meat plant etc.) must give notice of his suspicion to a Divisional Veterinary Officer.

If the person handling or examining the animal or carcase is a veterinary inspector or veterinary surgeon he shall, in addition to giving notice as aforesaid, take appropriate samples from the animal or carcase and forward them to a veterinary research laboratory for diagnosis. In other cases the Divisional Veterinary Officer is responsible for taking samples and forwarding them to a veterinary research laboratory.

The Order empowers the Department to serve a notice on the owner or person in charge of a diseased or suspect animal or carcase requiring its isolation and detention on the premises specified in the notice, and restricting movement of such animal or carcase and any other animal, carcase, litter or dung which may be on the premises. In addition, vehicles, machinery or equipment may not be moved out of the premises until they have been thoroughly cleansed and disinfected.

Where disease is confirmed on any premises they may be declared to be an infected place, and become subject to the Rules prescribed in Schedule 2.

The Department may serve a notice requiring the owner or occupier of any premises where a diseased animal or carcase is or was kept to cleanse and disinfect all parts of the premises and all vehicles, machinery and utensils used for or about the diseased animal or carcase.
