## WAGES COUNCILS

Retail Bespoke Tailoring Wages Regulation (Amendment) Order  
(Northern Ireland) 1977*Made* . . . . . 15th July 1977*Coming into operation* . . . . . 19th July 1977

The Department of Manpower Services, in exercise of the powers conferred on it by Section 10 of the Wages Councils Act (Northern Ireland) 1945(a), and now vested in it(b), hereby makes the following Order to give effect to wages regulation proposals received from the Retail Bespoke Tailoring Wages Council (Northern Ireland):—

*Citation*

1. This Order may be cited as the Retail Bespoke Tailoring Wages Regulation (Amendment) Order (Northern Ireland) 1977.

*Commencement*

2. The wages regulation proposals set out in the Schedule shall come into operation on the specified date.

*Interpretation*

3. In this Order the expression “the specified date” means 19th July 1977, provided that where, as respects any worker who is paid wages at intervals not exceeding seven days, that date does not correspond with the beginning of the period for which the wages are paid, the expression “the specified date” means as respects that worker, the beginning of the next such period following that date.

## SCHEDULE

## Statutory Minimum Remuneration

The Retail Bespoke Tailoring Wages Regulation Order (Northern Ireland) 1976(c) (Order N.I.T.R.B. (98)) shall have effect as if in the Schedule thereto there was inserted, after paragraph 5, a new paragraph as follows:—

## Paragraph 5A

*“Attack on Inflation—The Second Year” Supplement*

*In addition to the remuneration specified elsewhere in this Schedule there shall be paid a further supplement entitled “Attack on Inflation—The Second Year” Supplement as follows:—*

(i) *All workers 18 years of age and over—whichever is the greater of—*

(a) .. .. . *OR* .. .. .

(b) *5% of the worker's total gross earning for all hours worked subject to a maximum of £4.00 per week.*

(ii) *Workers aged:—*

*17 and under 18 years of age .. .. .*

*Under 17 years of age .. .. .*

<i>Per hour, subject to a maximum of 40 hours per week</i>	
	<i>6.25p</i>
	<i>5.00p</i>
	<i>4.375p</i>

## EXPLANATORY NOTE

*(This Note is not part of the Order but is intended to indicate its general purport.)*

This Order comes into operation on 19th July 1977.

The Schedule amends the Retail Bespoke Tailoring Wages Regulation Order (Northern Ireland) 1976 (Order N.I.T.R.B. (98)) by increasing the statutory minimum remuneration fixed by that Order.

New provisions in the Schedule are printed in italics.
